IRVING, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LANDS DELINEATED ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: BEGINNING AT THE INITIAL POINT, A 2"x36" GALV. I.P., SET 6" BELOW SURFACE, FROM WHICH, THE N.E. CORNER OF THE JOHN LEISER D.L. NO. 53, T27S., R6W., W.M. BEARS N81°51'W 30.2 FT. & N1°45' E 1192.9 FT., THENCE N81°51'W 101 FT. TO A 1" I.P. AT THE INTERSECTION OF THE NORTHERLY R/W LINE OF HARVARD AVE AND THE EASTERLY R/W LINE OF SAID BALLE ST., AS DEDICATED BY BAUER'S ADDITION, THENCE N1°45' E 1196.6 FT. ALONG THE EASTERLY R/W LINE OF SAID BALLE ST. TO A 1" I.P., AND CONTINUING N1°45' E 212 FT. TO THE LOW BANK OF THE SOUTH UMPQUA RIVER, THENCE, FOLLOWING SAID LOW BANK OF RIVER, UPSTREAM, N14°28' E 104.8 FT., N69°06' E 81.3 FT., S89°43' E 100 FT., N76°10' E 68.5 FT., N68°41' E 117 FT., & N89°37' E 129.2 FT., THENCE S1°36' W 35.0 FT. TO A 1" I.P., & CONTINUING S1°36' W 244 FT. TO A 1" I.P., THENCE S88°15' E 18.2 FT. TO A 1" I.P., THENCE S1°48' W 230.6 FT. TO A 1" I.P. AT THE N.E. CORNER OF MARILL ST., AS DEDICATED BY PLAT OF MAYNARD'S HARVARD AVE ADDITION; THENCE N88°12' W 430 FT. TO A 1" I.P. AT THE N.W. CORNER OF SAID MARILL ST. THENCE S1°48' W 816.8 FT. ALONG THE WESTERLY R/W LINE OF SAID MARILL ST. TO A 1" I.P. IN THE NORTHERLY R/W LINE OF HARVARD AVE; THENCE N81°51' W 4711 FT. ALONG SAID NORTHERLY R/W LINE OF HARVARD AVE, TO THE POINT OF BEGINNING, CONTAINING 149 ACRES MORE OR LESS, IN SECTION 13, T27S., R6W., W.M., DOUGLAS COUNTY, OREGON.
