

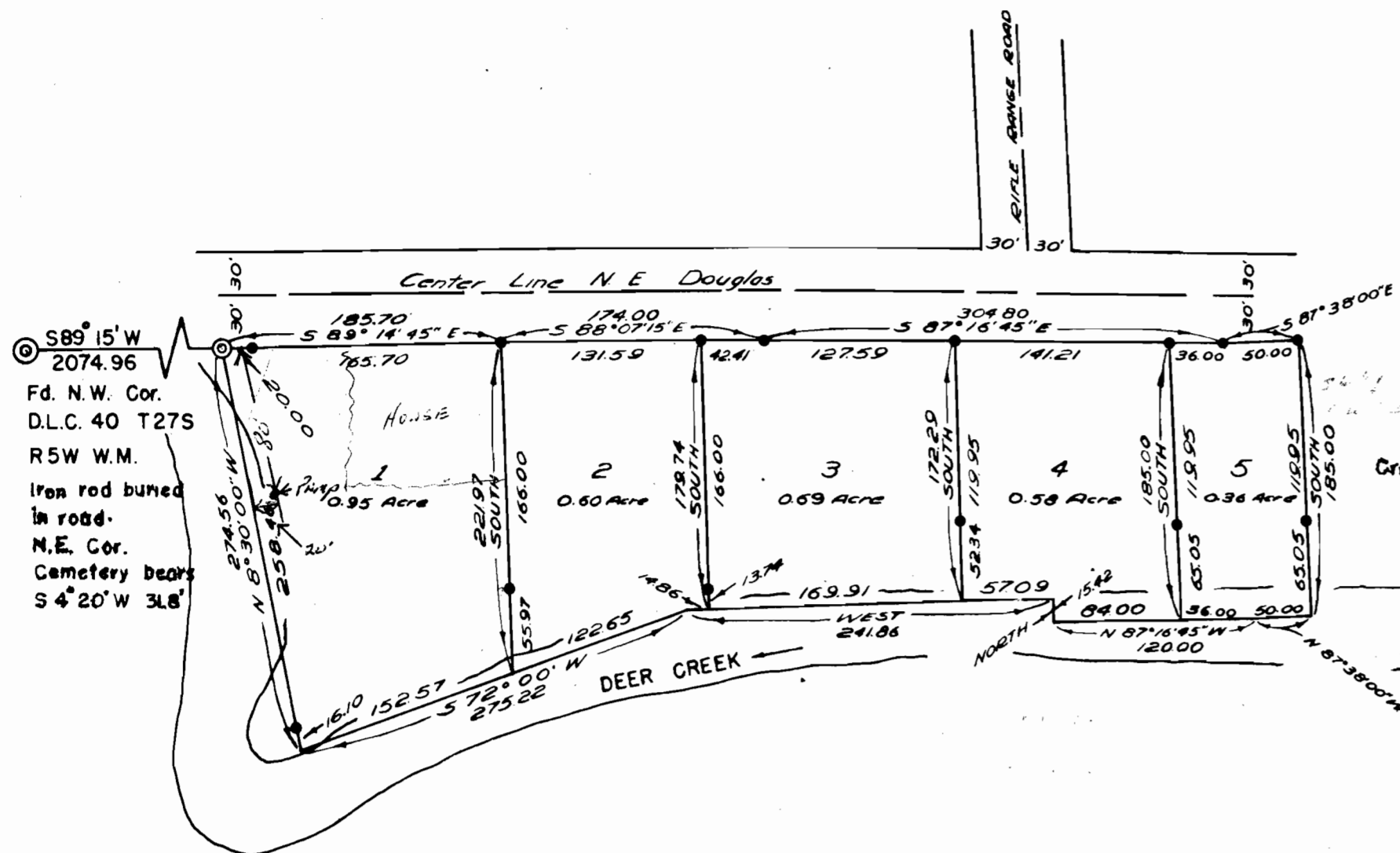
VANCE SUBDIVISION

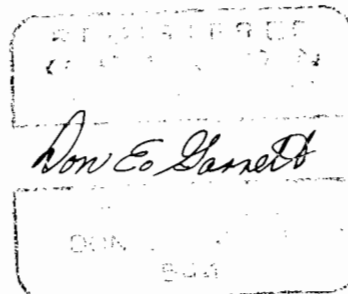

CERTIFICATE OF SURVEYOR

I, DON E. GARRETT, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE LANDS DELINEATED ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: Beginning at the Initial Point, a 2"X36" Galv. Iron Pipe set 6" below the surface of the ground, set in the South Right of Way Line of North East Douglas Street, from which the North West Corner of the Thomas Stevens D.L.C. 40 T.27S. R5W W.M. bears S89°15'00"W 2074.96 feet; thence along said right of way line as follows: S89°14'45"E 185.70 ft. to a 5/8" Iron Rod; S88°07'15"E 174.00 ft. to a 5/8" Iron Rod; S87°16'45"E 304.80 ft. to a 5/8" Iron Rod; S87°38'00"E 50.00 ft. to a 5/8" Iron Rod; thence leaving said Southerly right of way line and running South 185.00 ft. to a point in the channel of Deer Creek; thence along the channel of Deer Creek as follows: N87°38'00"W 50.00 ft.; N87°16'45"W 120.00 ft.; North 15.42 ft.; West 241.86 ft.; S72°00'W 275.22 ft.; thence leaving said channel and running N8°30'00"W 274.56 ft. to the place of beginning. Containing 3.18 Acres of land more or less.

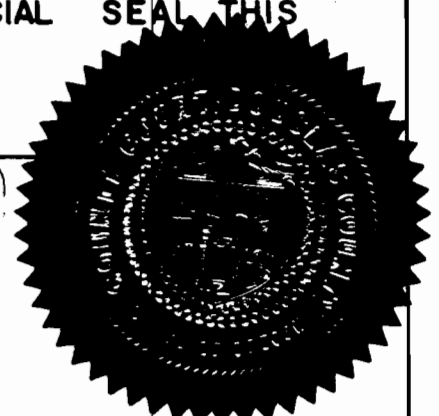

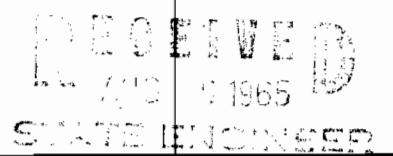
