IRVING, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE LANDS DELINEATED ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION: - BEGINNING AT THE INITIAL POINT, A 2"x36" GALV. IRON PIPE, 6" BELOW SURFACE, IN THE EASTERLY R/W LINE OF KENDALL AVE AND THE WESTERLY LINE OF LOT 2, ELLISON'S ACRES, AS PLATTED AND FILED IN THE OFFICE OF THE COUNTY CLERK OF DOUGLAS COUNTY, OREGON, FROM WHICH PIPE THE CORNER TO SECTIONS 23, 24, 25, 26, T27S, R6W, WM BEARS S80°48' W 2524.2 FT.; THENCE N3°13' W 4250 FT, ALONG SAID R/W AND LOT LINE, TO A FD. 3/4" I. PIPE AT THE NW CORNER OF SAID LOT 2; THENCE S89°36' E, ALONG THE LINE BETWEEN LOTS 2, & 3, SAID ELLISON'S ACRES, 274.5 FT. TO A FD. 3/4" I. PIPE ON THE HIGH BANK OF THE SOUTH UMPQUA RIVER, AND CONTINUING 20.0 FT. TO THE N.E. COR OF SAID LOT 2, BEING ON THE LEFT BANK OF SAID RIVER; THENCE S9°13' E 643.8 FT., UPSTREAM, ALONG SAID LEFT BANK OF RIVER, TO THE S.E. CORNER OF SAID LOT 2; THENCE N89°36' W 1875 FT., ALONG THE LINE BETWEEN LOTS 1 & 2, SAID ELLISON'S ACRES, TO A 3/4" I. PIPE ON THE HIGH BANK OF SAID RIVER, AND CONTINUING 343.2 FT. TO A FD. 3/4" I. PIPE AT THE S.W. CORNER OF SAID LOT 2; THENCE N3°13' W 2110 FT., ALONG THE EASTERLY R/W LINE OF KENDALL AVE. & WESTERLY LINE OF SAID LOT 2, TO THE POINT OF BEGINNING, CONTAINING 4.78 ACRES, MORE OR LESS, IN SECTION 24, T27S, R6W, WM, DOUGLAS COUNTY, OREGON.

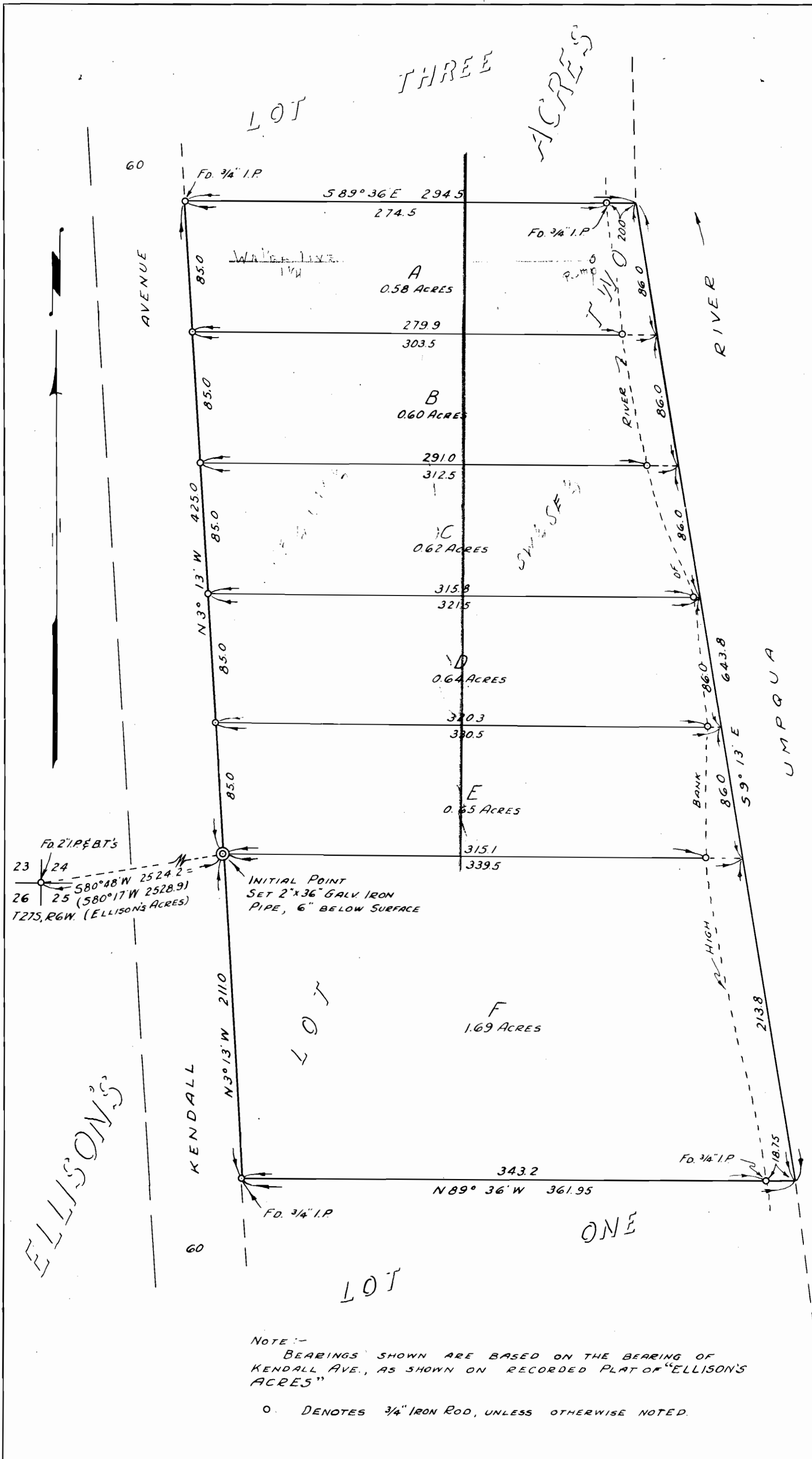
