AFFIDAVIT

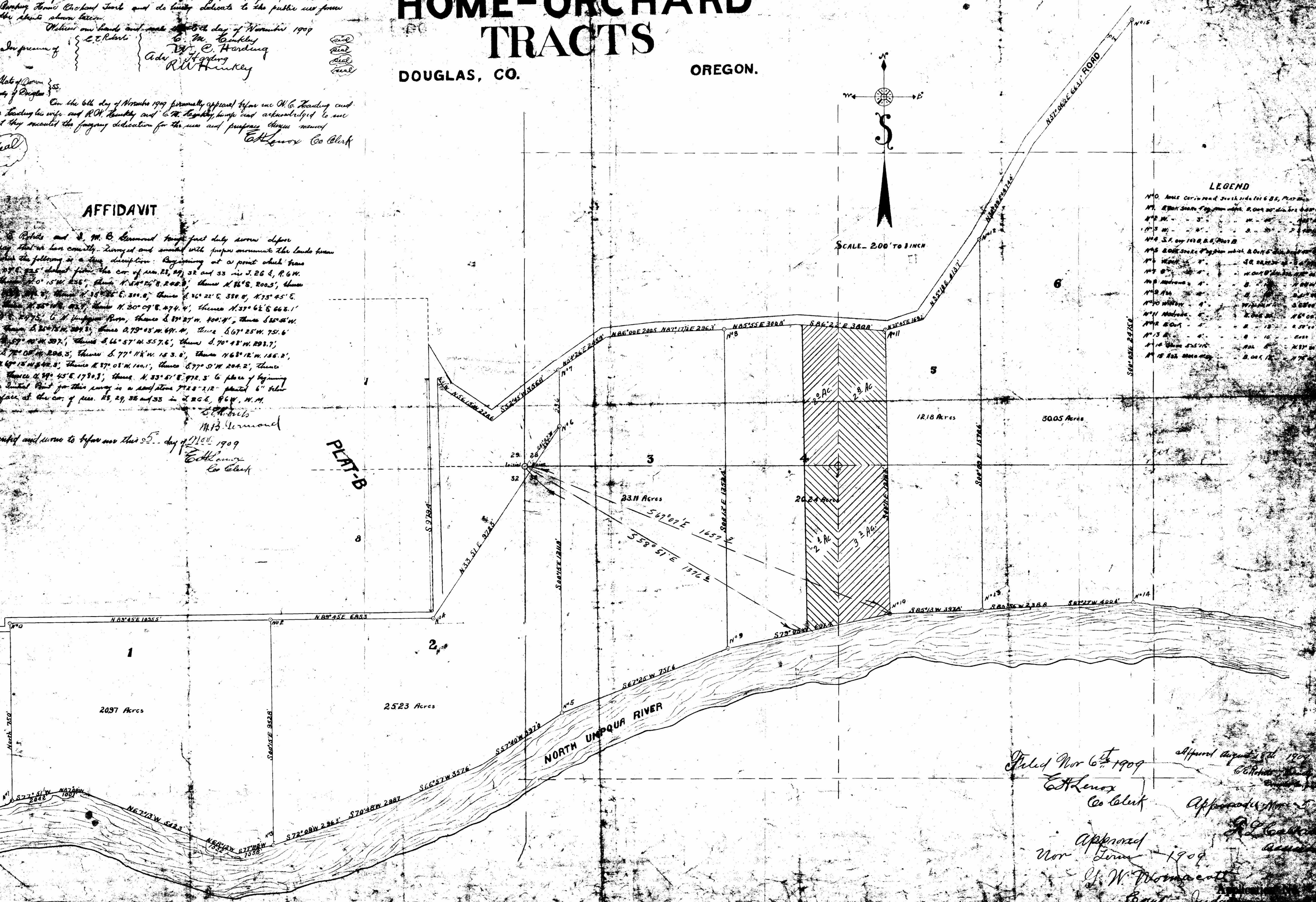
