

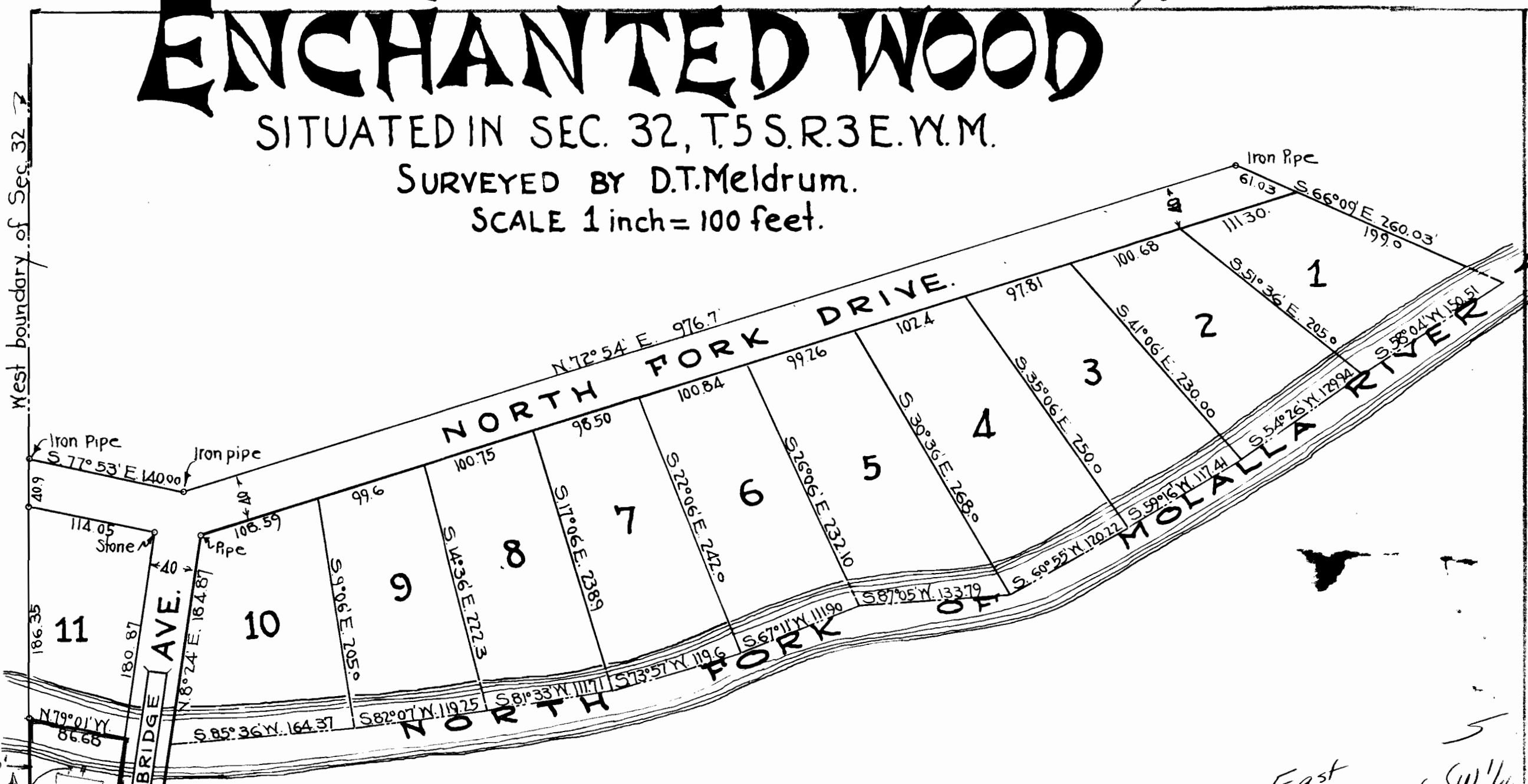
# PLAT OF ENCHANTED WOOD

## CERTIFICATE.

 I, D.T. Meldrum, being first duly sworn, depose and say that I have correctly surveyed and marked with lawful monuments the land represented on the attached plat of "ENCHANTED WOOD" situated in Sec. 32 T.5 S.R.3 E. Y.M. that I set a Gal. Iron pipe, 2" x 3/8" - 6" below the surface of the ground for the initial point of said plat and that said plat is correctly bounded and described as follows to wit: Beginning in the West boundary of Sec. 32 T.5 S.R.3 E. Y.M. at a point that is 330.25 feet North of the SW. Corner of said Section; Running thence North tracing the West line of Sec. 32 aforesaid 599.50 feet to an iron pipe; thence S. 77° 53' E. 140.00 feet to an iron pipe; thence N. 72° 54' E. 976.7 feet to an iron pipe; thence S. 66° 09' E. 260.03 feet to the center of the North Fork of the Molalla River; thence tracing the thread of the North Fork of the Molalla River down stream S. 58° 04' W. 150.51 feet; thence S. 54° 26' W. 129.94 feet; thence S. 59° 16' W. 117.41 feet; thence S. 60° 55' W. 120.22 feet; thence S. 87° 05' W. 133.79 feet; thence S. 67° 11' W. 111.90 feet; thence S. 73° 57' W. 119.60 feet; thence S. 81° 33' W. 111.71 feet; thence S. 82° 07' W. 119.25 feet; thence S. 85° 36' W. 164.37 feet; thence leaving said stream S. 8° 24' W. 293.40 feet to an iron pipe; thence S. 53° 58' W. 101.40 feet to the place of beginning.

That I have subdivided said tract into smaller tracts, drives and avenues as shown hereon, and that the attached map truly represents the dimensions of each tract and is accurately constructed on a scale of 1 inch to 100 feet.

## DEDICATION.

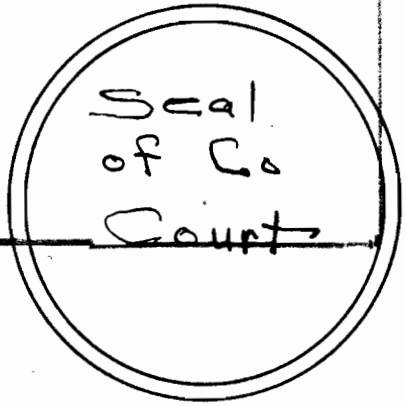
