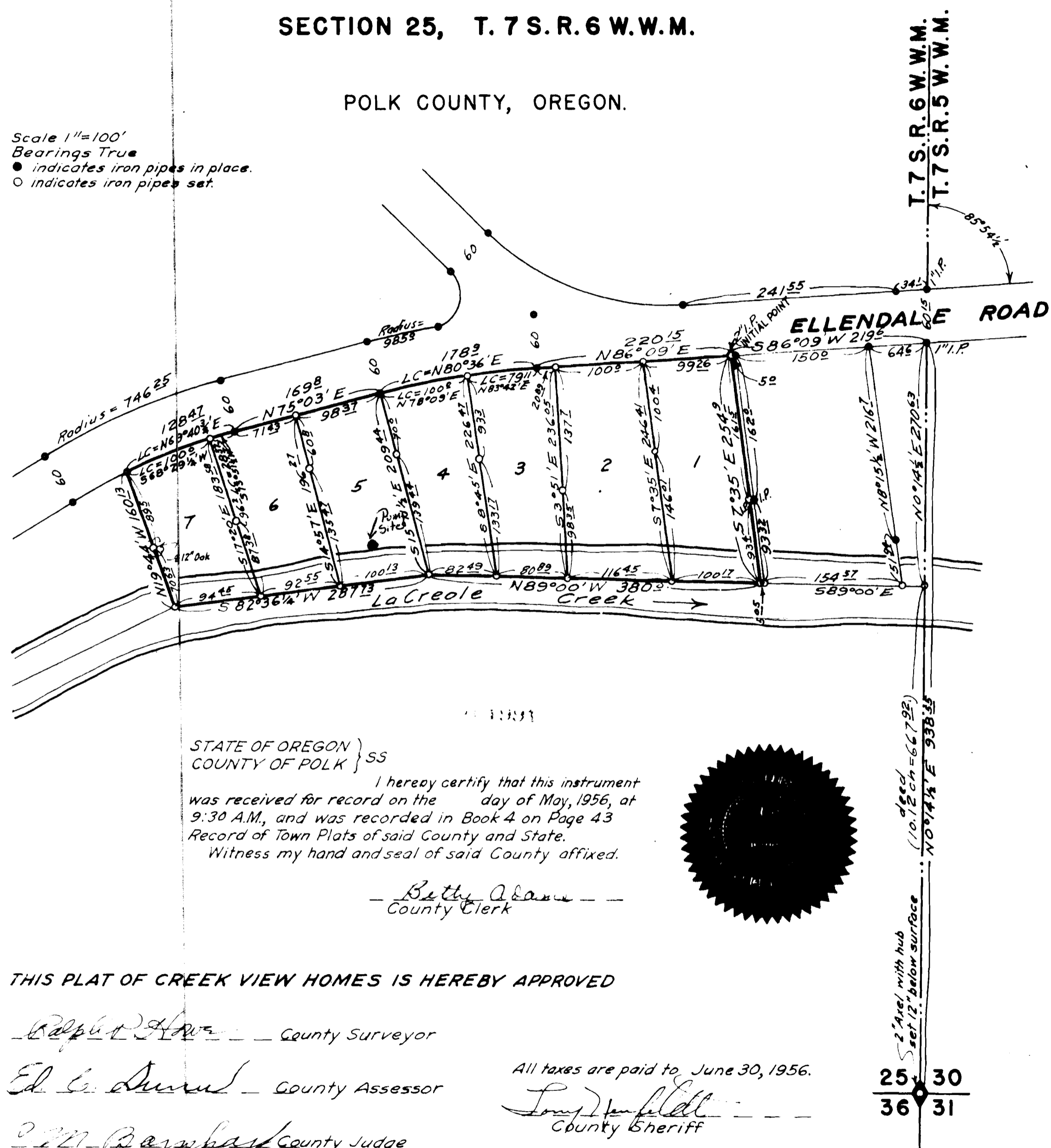


CREEK VIEW HOMES

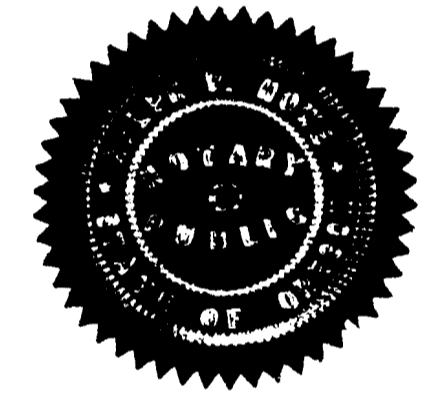

SURVEYORS CERTIFICATE

I, Ralph P. Howe, first being duly sworn, depose and say that I am a duly Licensed Land Surveyor in the State of Oregon, and that I have correctly surveyed and marked with proper monuments the land and lots represented by this by this plat of CREEK VIEW HOMES, the INITIAL POINT of which is a 2"x36" iron pipe set 6" below the surface of the ground at a point 938.55 feet N 0° 14 1/4' E and 219.6 feet S 86° 09' W from the Southeast corner of Section 25 in T. 7 S. R. 6 W. W. M., in Polk County, Oregon; and running thence S 7° 35' E 254.9 feet to a point in the LaCreole Creek from which an iron pipe bears N 7° 35' W 93.4 feet; thence N 89° W 380.0 feet to a point in said Creek from which an iron pipe bears N 15° 11 1/2' W 139.44 feet; thence S 82° 36 1/4' W 287.73 feet to a point in said Creek from which the center of a 12" Oak Tree bears N 19° 44' W 72.63 feet; thence N 19° 44' W 160.13 feet to an iron pipe on the South line of the County Road; thence along the arc of a 686.25 foot radius curve to the right (the long chord of which bears N 69° 40 3/4' E 128.47 feet) to an iron pipe; thence N 75° 03' E 169.8 feet to an iron pipe; thence along the arc of a 925.0 foot radius curve to the right (the long chord of which bears N 80° 36' E 178.9 feet) to an iron pipe; thence N 86° 09' E 220.15 feet to the place of beginning.
All bearings are true bearings and the dimensions of the lots are as shown on the accompanying plat.
