I, G. ROBERT LECKLIDER, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION:

BEGINNING AT THE INITIAL POINT, A 2" X 36" GALVANIZED IRON PIPE ON THE WEST-ERLY BOUNDARY OF COUNTY ROAD NO. 200 FROM WHICH THE SECTION CORNER OF SECTIONS 13, 18, 19 AND 24, T 26 S, R 38 4 W, W.M., DOUGLAS COUNTY, OREGON BEARS S 50° 03' 30" E - 4730.74 FT.; THENCE ALONG THE SOUTHERLY BOUNDARY OF SAID COUNTY ROAD ALONG A 606.98 FT. RADIUS CURVE TO THE LEFT 666.38 FT. TO A 5/8" IRON ROD, THE CHORD OF WHICH BEARS N 41° 04' W - 633.36 FT.; THENCE N 72° 31' W - 265.62 FT. TO A 5/8" IRON ROD; THENCE ALONG A 924.47 FT. RADIUS CURVE TO THE LEFT 660.96 FT. TO A 5/8" IRON ROD, THE LONG CHORD OF WHICH BEARS S 87° 00' W - 647.00 FT.; THENCE S 66° 31' W - 351.19 FT. TO A 5/8" IRON ROD; THENCE ALONG A 1399.71 FT. RADIUS CURVE TO THE LEFT 438.97 FT. TO A 5/8" IRON ROD, THE LONG CHORD OF WHICH BEARS S 57° 32' W - 437.13 FT.; THENCE S 48° 33' W - 174.43 FT. TO A 5/8" IRON ROD; THENCE ALONG A 1462.40 FT. RADIUS CURVE TO THE RIGHT 17.87 FT. TO A 3/4" IRON ROD, THE LONG CHORD OF WHICH BEARS S 48° 54' W - 17.78 FT.; THENCE LEAVING SAID COUNTY ROAD S 01° 23' W - 244.93 FT. TO A 5/8" IRON ROD; THENCE CONTINUING S 03° 40' W TO THE WATERS EDGE OF THE RIGHT SIDE OF THE NORTH UMPQUA RIVER; THENCE EASTERLY ALONG THE WATERS EDGE OF THE RIGHT SIDE OF THE NORTH UMPQUA RIVER TO A POINT ON THE WESTERLY BOUNDARY OF COUNTY ROAD NO. 200; THENCE ALONG THE WESTERLY BOUNDARY OF SAID ROAD N 26° 12' E - 321.43 FT. TO A 5/8" IRON ROD; THENCE ALONG A 606.98 FT. RADIUS CURVE TO THE LEFT 379.46 FT. 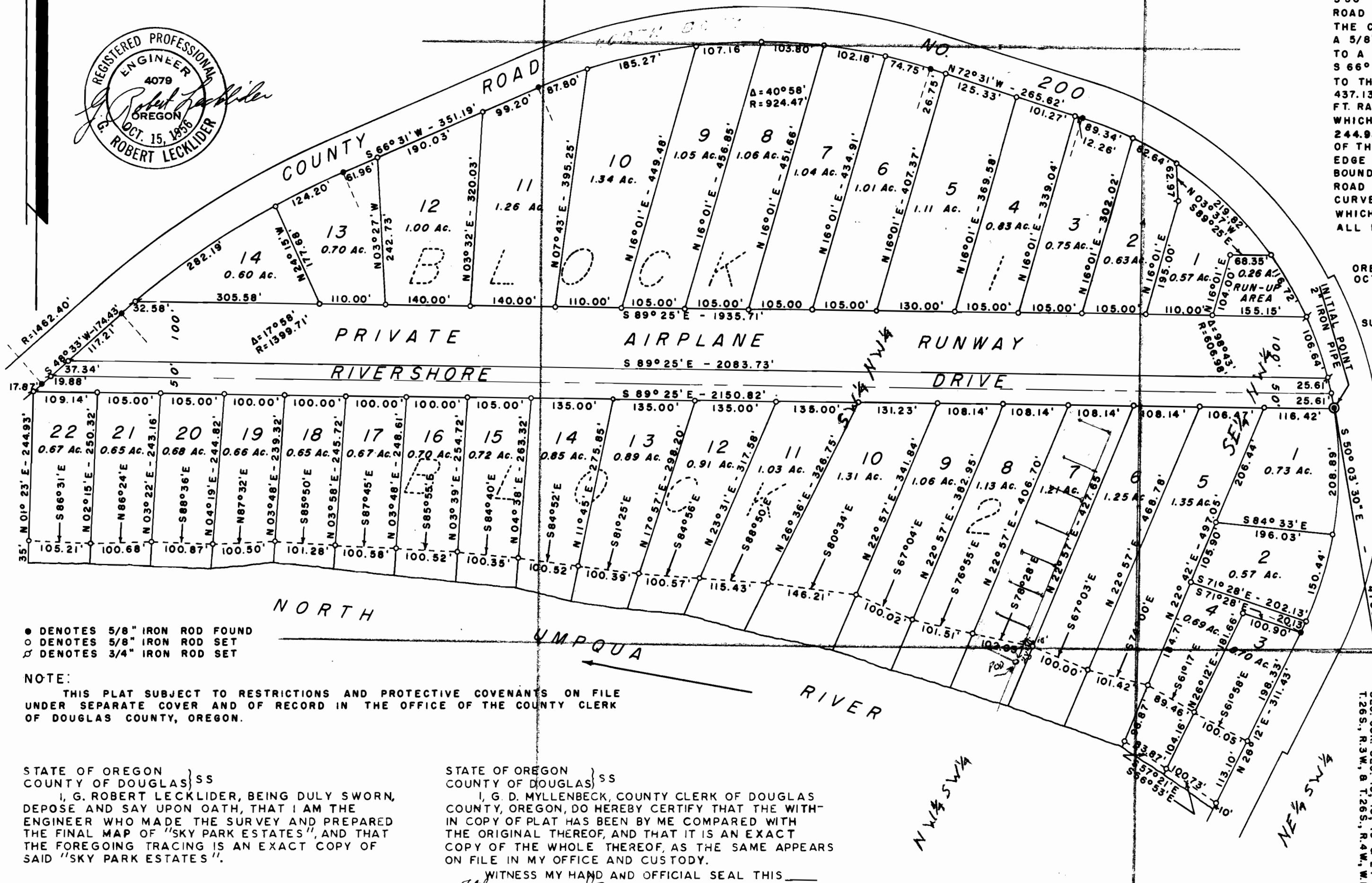
