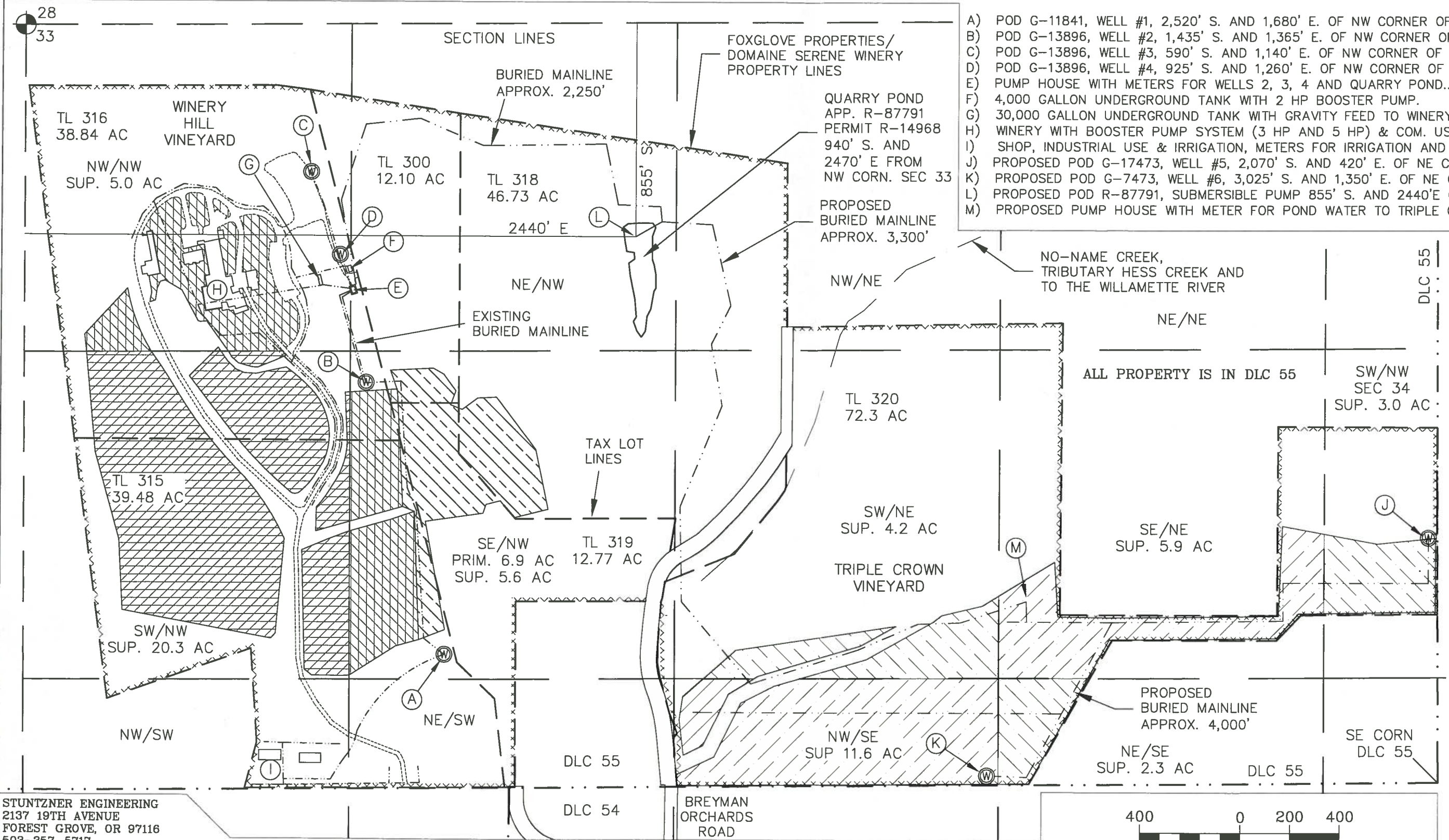
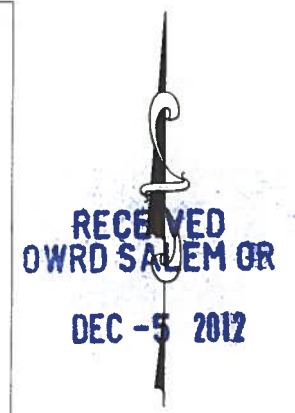


SURFACE WATER APPLICATION MAP

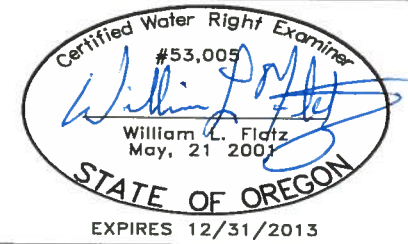


- A) POD G-11841, WELL #1, 2,520' S. AND 1,680' E. OF NW CORNER OF SEC. 33.

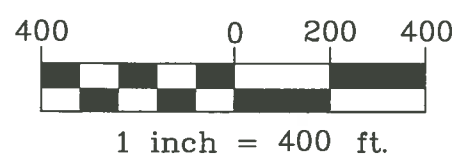
