

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **POD 5, located on a neighboring property, consists of a low area in an approximately 15-foot-long side channel connected to the Crooked River in which a Parma pump is seasonally placed. The Parma pump has a theoretical capacity of 1.87 cfs. Approximately 100 feet of buried 10-inch-diameter steel pipe conveys the pumped water to a partnership ditch that extends to the southern end of the ranch and ends at a bulge in the system. An unlined ditch extending from the bulge conveys the water by gravity past lands irrigated under Certificate 86200. This ditch connects to unlined ditches that are used to flood irrigate the 12.5 acres of lands on the eastern side of the Crooked River.**

The capacity of the Parma pump is inferred to be the limiting factor to the conveyance and distribution system because the main ditch and distribution ditches can convey the diverted water.

Additional information on the diversion, conveyance and distribution systems for this right is contained in Claim of Beneficial Use for T-8827 completed in December 2009.

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **The proposed changes would only affect POD 5 and the primary irrigation right.**

POD 5 consists of a low area in an approximately 15-foot-long side channel connected to the Crooked River in which a Parma pump is seasonally placed. Approximately 100 feet of buried 10-inch-diameter steel pipe conveys the pumped water to a partnership ditch that extends to the southern end of the ranch and ends at a bulge in the system. Water in the bulge is forwarded to hand lines using a portable 6-inch by 4-inch Berkley pump powered by a Case International diesel engine. This pump has a theoretical capacity of 4.65 cfs so the 1.87 cfs theoretical capacity of the Parma pump is inferred to be the limiting factor for the conveyance and distribution system because the main ditch can convey the diverted water.

Additional information on the diversion, conveyance and distribution systems for this right is contained in Claim of Beneficial Use for T-8827 completed in December 2009.
