

The original application listed the Lucas Well (Well #1) and the New Park Well (Well #2) as the source(s) of water for this permit. The New Park Well was drilled and proved successful. It is currently being used by the City.

The development of the Lucas Well proved to be unsatisfactory due to the lack of sufficient water from this source. Because of this, the City has-since the permit issuance-drilled and developed a substitude well site-known as the 'Church Well' to replace the Lucas Well.

The Church Well is currently being used by the City. The Church Well and New Park Well both obtain their water from a common under-lying basalt formation.
