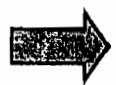

of P. O. Box 128, Stayton, State of Oregon, 97383, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Lake of the Woods

a tributary of Seldom Creek for the purpose of domestic use for one family

under Permit No. 42889 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 16, 1978 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SW 1/4 NW 1/4), Section 14, T. 37 S., R. 5 E., W. M., 1900 feet South and 235 feet East from the NW Corner, Section 14

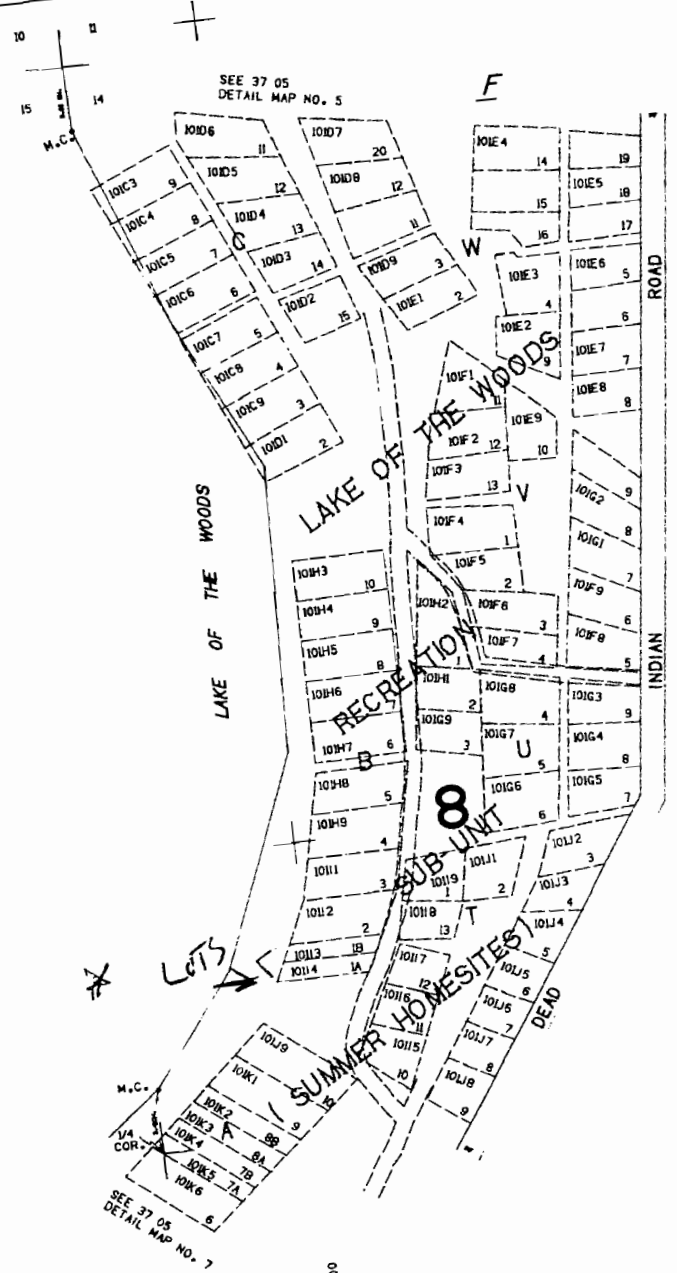
