confirms the right to use the waters of A WELL in the SALMON RIVER BASIN for the purpose of IRRIGATING 5.0 ACRES AND PARK USE.

The right has been perfected under Permit G-10361. The date of priority is SEPTEMBER 29, 1983. The right is limited to not more than 0.075 CUBIC FOOT PER SECOND BEING, 0.063 CFS FOR IRRIGATION AND 0.012 CFS FOR PARK USE, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SW 1/4, SECTION 31, T 2 S, R 7 E, W.M.; 331 FEET SOUTH AND 270 FEET WEST FROM THE NE CORNER OF THE SE 1/4 SW 1/4 OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
