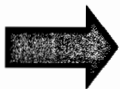

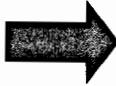

Additional remarks: The existing Certificate includes a total of 125.6 acres in this quarter section. Ivan Cook sold all of the NW quarter-quarter section (tax lot 202) and a portion of the SW quarter-quarter section (tax lots 204 and 205.) This transfer involves moving the portions of the remain water right to new ground within the same Section (tax lot 200.) The other portions of the water right are addressed under two separate transfers, one in the name of Pioneer Hi-Bred International, Inc. and the other in the name of Hermiston Partners 1.
