## Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

### **Findings of Fact**

#### Background

- On April 23, 1998, ROBERT AND PAMELA ZIELINSKI filed an application for additional points of appropriation under Permit G-12169. The Department assigned the application number T-7989.
- 2. The authorized period for completion of construction and complete application of water to beneficial use under Permit G-12169 expired on October 1, 1998. On May 26, 1999, the applicants filed a Claim of Beneficial Use for Permit G-12169.
- 3. On September 24, 2010, the Department issued a Final Order proposing to deny Permit Amendment Application T-7989 and mailed a copy to the applicants. The Final Order cover letter set forth a deadline of October 25, 2010, for the applicant to correct the deficiencies in the Claim of Beneficial Use for Permit G-12169. On October 27, 2010, the applicant submitted the information needed to correct the outstanding deficiencies.
- 4. On April 1, 2011, Certificate 86846 was issued for the water use under Permit G-12169.
- 5. On May 13, 2011, the applicants submitted an amended application converting the application from a Permit Amendment under Permit G-12169 to a transfer under Certificate 86846.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

6. The portion of the right to be transferred is as follows:

Certificate: 86846 in the name of ROBERT AND PAMELA ZIELINSKI (perfected

under Permit G-12169)

Use: IRRIGATION OF 36.7 ACRES

Priority Date: JANUARY 31, 1994

Rate: 0.46 CUBIC FOOT PER SECOND

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed

2.5 acre-feet per acre for each acre irrigated during the irrigation season of

each year.

Period of Use: March 1 through October 31.

Source: A WELL (WELL NO. 4) within the PATTERSON CREEK BASIN

7. Transfer Application T-7989 proposes two additional points of appropriation approximately 2200 feet southwest to Well 3, and 2800 feet northwest to Well 5 from the existing point of appropriation to:

- 8. Notice of the application for transfer was published on April 28, 1998, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 9. On August 25, 2011, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-7989 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of September 25, 2011, for the applicants to respond. The applicants requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

# Transfer Review Criteria (OAR 690-380-4010)

- 10. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the right is subject to forfeiture under ORS 540.610. Water Right Certificate 86846 was issued on April 1, 2011.
- 11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of Transfer Application T-7989.
- 12. The proposed change would not result in enlargement of the right.
- 13. The proposed change would not result in injury to other water rights.

## **Determination and Proposed Action**

The additional points of appropriation proposed in Transfer Application T-7989 appear to be consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the application will be approved.

If Transfer Application T-7989 is approved, the final order will include the following:

- 1. The additional points of appropriation proposed in Transfer Application T-7989 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 86846 and any related decree.
- 3. Water right certificate 86846 is cancelled.
- 4. The quantity of water diverted at the additional points of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.
- 5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 6. Water shall be acquired from the same aquifer (water source) as the original point of appropriation.
- 7. The approved change shall be completed and full beneficial use of the water shall be made on or before **October 1, 2013**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.

8. When satisfactory proof of the completed change is received, a new certificate confirming the right transferred will be issued.
