AFFIDAVIT FOR THE DIMINISHMENT OF A WATER RIGHT PERMIT

I, Kent R. Madison, residing at 29299 Madison Road, Echo, OR 97826, being first duly sworn depose and say:

- 1. I am the legal owner of the property described as tax lot number 4700, within the NW1/4 SW1/4, Section 1, Township 3 North, Range 27 East, of the Willamette Meridian, in Umatilla County, Oregon, as shown on the attached map and made part of this affidavit;
- 2. A portion of water right permits S51017 and S54675, issued to Kent R. Madison for use of water from the Columbia River for irrigation is appurtenant to my property;
- 3. The portion of water right permits S51017 and S54675, that will be covered by primary Westland Irrigation District rights being transferred in under 2011 Westland Irrigation District permanent transfer notice #2011-01, are shown on the attached map and described as follows: The rights to the use of water from the Columbia River, for primary irrigation purposes under permits S51017 and S54675, are located within:

- 4. I request that said portion of the rights described above be diminished to supplemental irrigation.

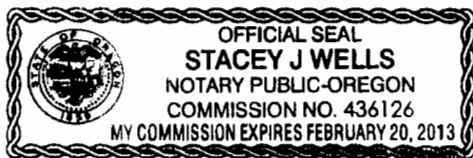
