**2.4 Flow protection.** The Trustee will regulate use of water from the source, subject to prior appropriation and the agency enforcement guidance, to assure the water is delivered to the point of diversion, and through the reach past junior downstream users, so long as flow is sufficient to meet the demand under priority date of the new instream use (see Section 2.2). As part of regulation activities the watermaster or a designee has access to the point of diversion and place of use for the water rights involved in this lease. No party is required to continuously measure the flow of the waterway described in Section 2.2.

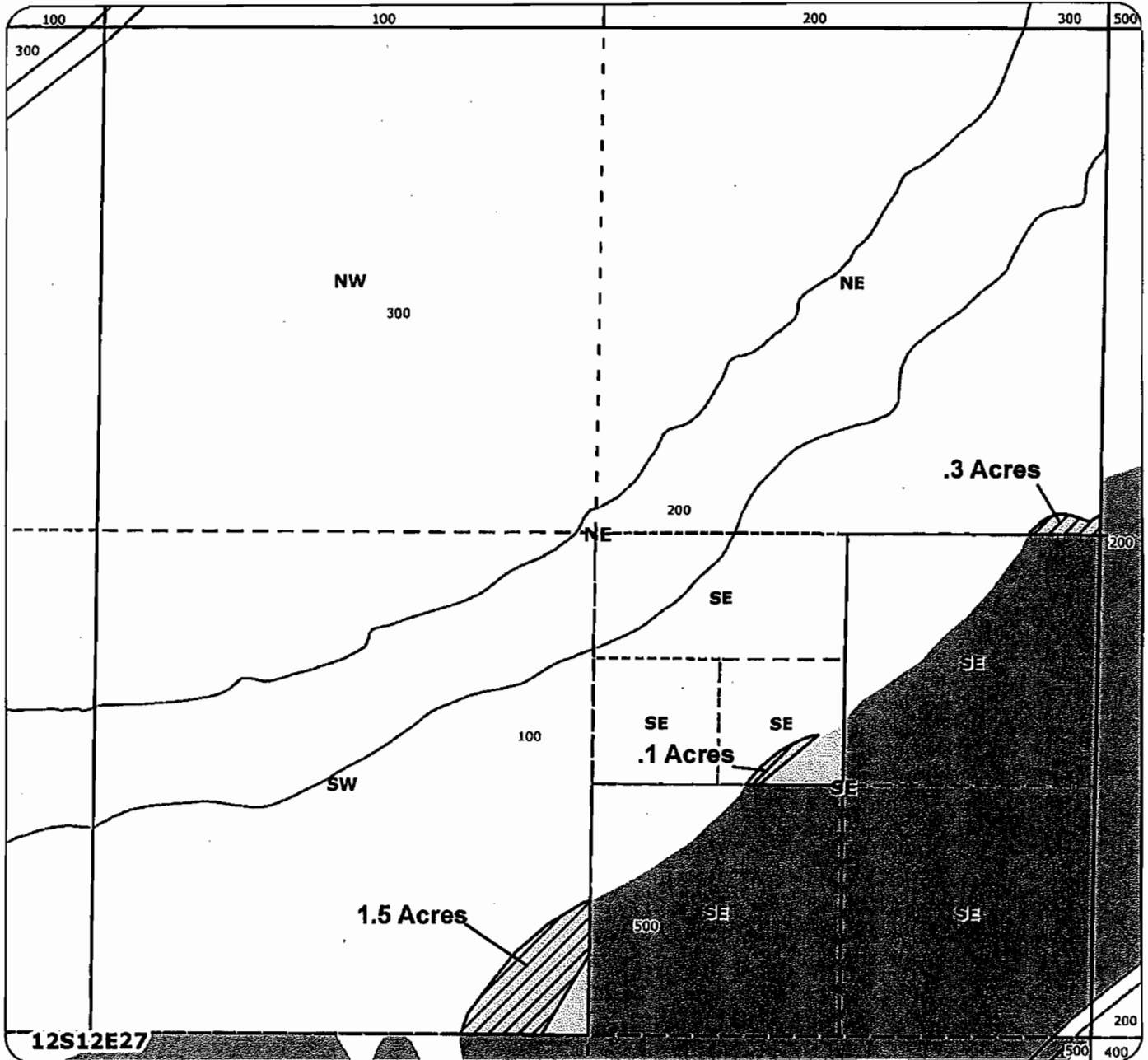

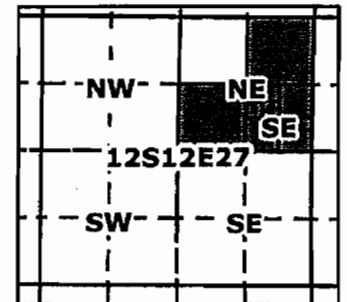
# 2012 North Unit Irrigation District Instream Lease Map



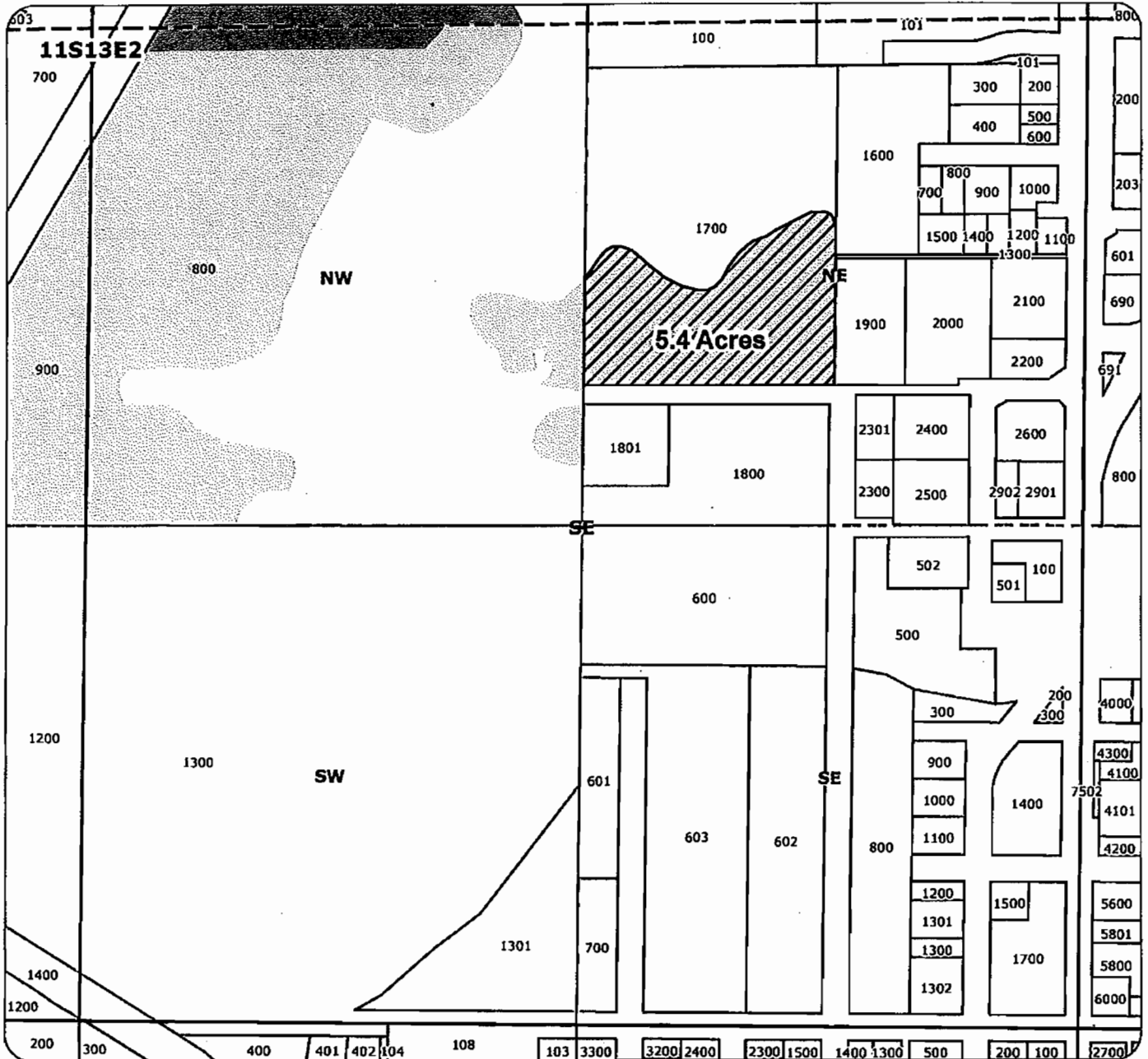

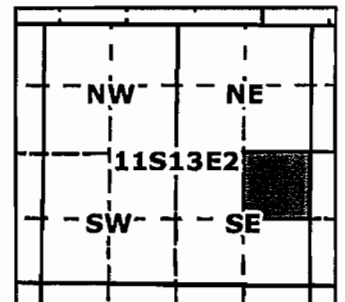
# 2012 North Unit Irrigation District Instream Lease Map

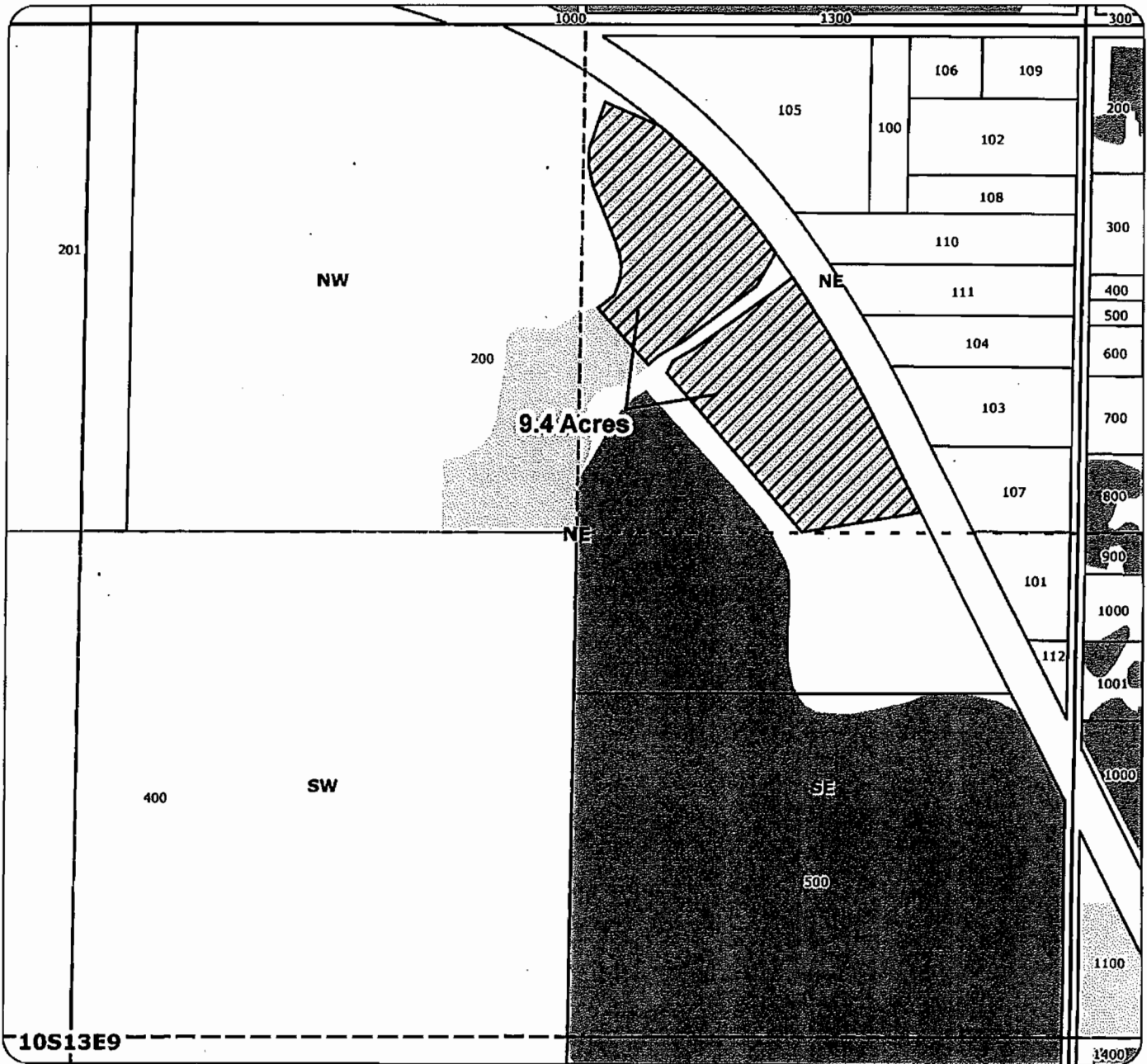

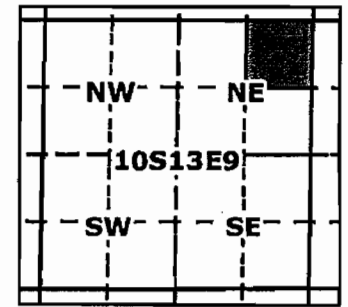
# 2012 North Unit Irrigation District Instream Lease Map

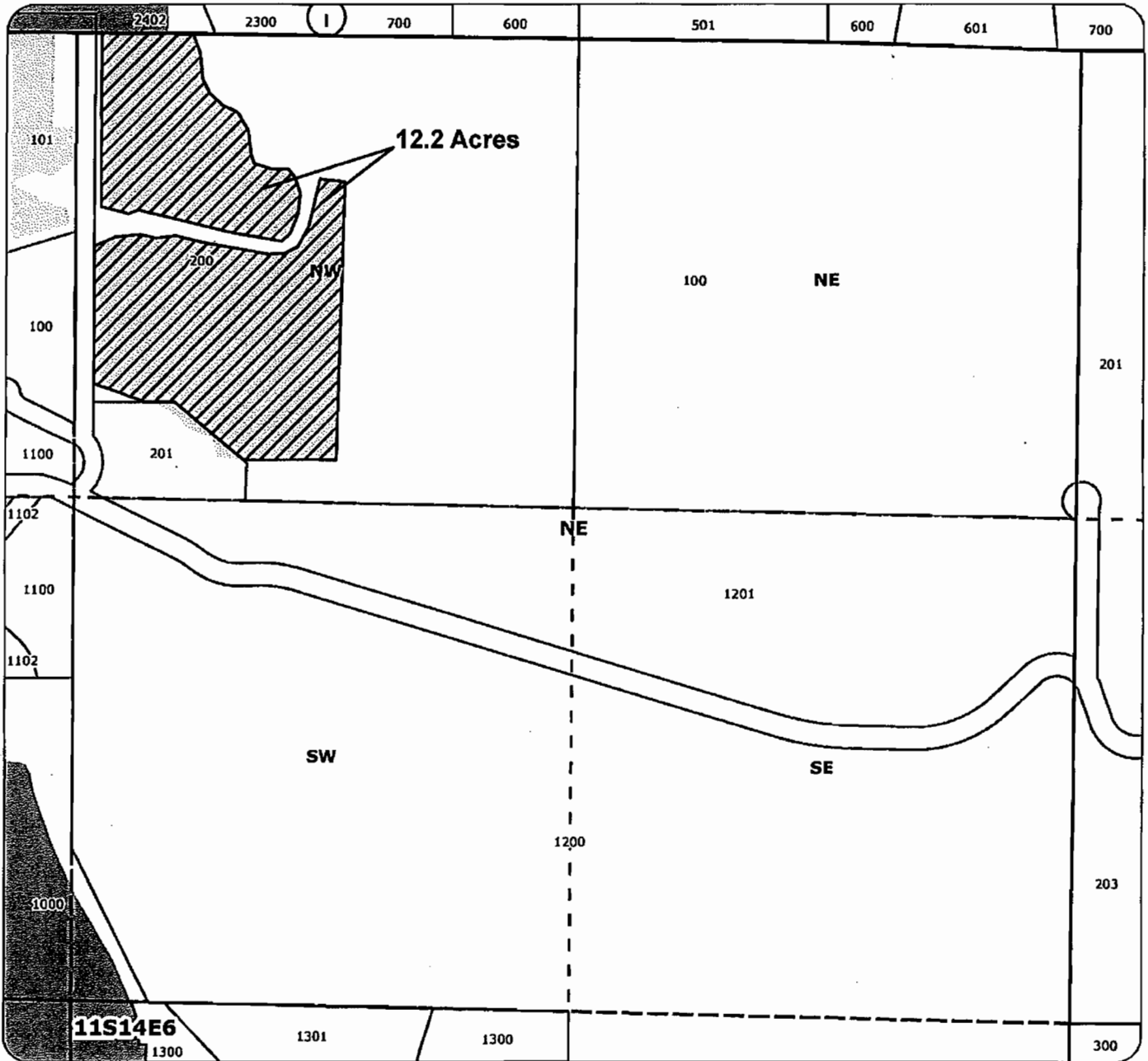

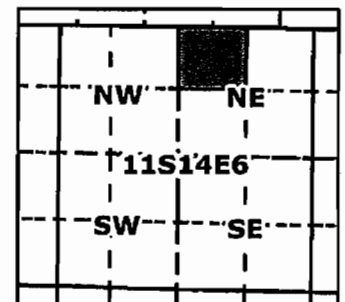
# 2012 North Unit Irrigation District Instream Lease Map

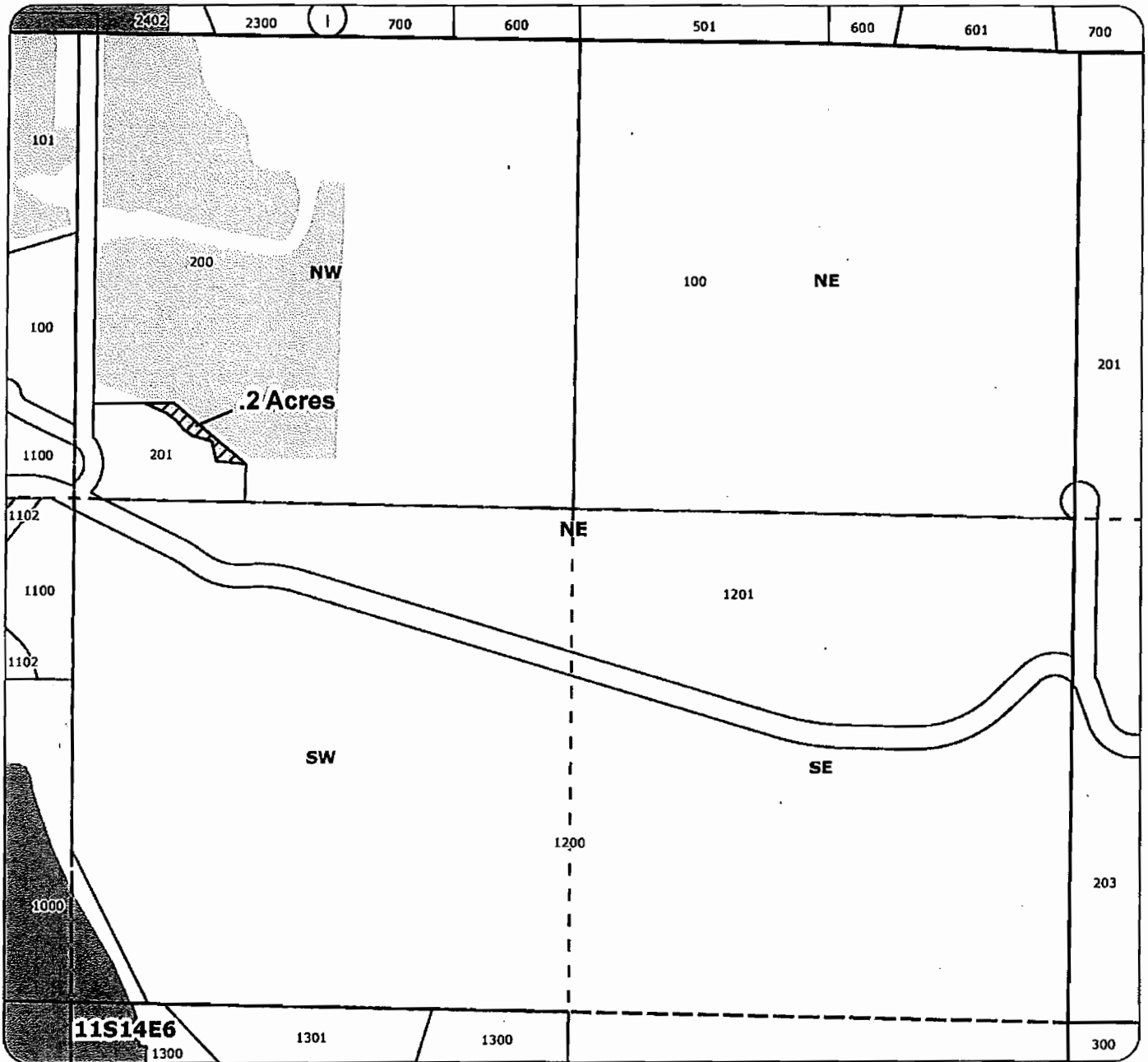

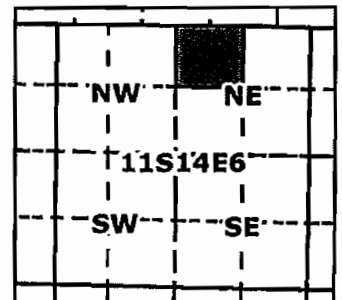
# 2012 North Unit Irrigation District Instream Lease Map
