SUBJECT: Water Right Transfer Application T-11134

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-11134. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the Department's notice.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

## Findings of Fact

## Background

- 1. On September 20, 2010, the CITY OF PRINEVILLE filed an application to change the place of use under Certificates 75489, 76012, 76013, 83850, and 83857. The Department assigned the application number T-11134.
- 2. On March 10, 2011, the applicant submitted an amendment to the application for Certificates 76012 and 83857, clarifying the types of use to be transferred.
- 3. On March 13, 2012, the applicant amended the transfer application for Certificates 76012 and 76013 reducing the number of acres proposed for transfer.
- 4. The portion of the first right to be transferred is as follows:

- 14. Notice of the application for transfer was published on September 28, 2010, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 15. On March 10, 2011, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11134 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of April 12, 2011, for the applicant to respond. On April 20, 2011, the applicant requested the Transfer Application be placed on administrative hold until October 20, 2011. The request was granted. On November 2, 2011, the applicant requested the application be placed on administrative hold for an

- additional 120 days. The request was granted and the application was place on administrative hold until February 20, 2012.
- 16. On March 14, 2012, the Department issued a 2<sup>nd</sup> draft Preliminary Determination and sent a copy to the applicant. On March 26, 2012, the applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer. The applicant also requested additional time to complete the changes until October 1, 2016.

# Transfer Review Criteria [OAR 690-380-4010(2)]

- 17. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 18. Diversion structures and ditches sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11134.
- 19. The proposed changes would not result in enlargement of the rights.
- 20. The proposed changes would not result in injury to other water rights.

## **Determination and Proposed Action**

The changes in place of use proposed in Transfer Application T-11134 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-11134 is approved, the final order will include the following:

- 1. The changes in place of use proposed in Transfer Application T-11134 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 75489, 76012, 76013, 83850, 83857, and any related decree.
- 3. Water right certificates 75489, 76012, 76013, and 83857 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer.
- 4. Water right certificate 83850 is modified. The Department will issue a superseding certificate describing the right when it determines that is necessary for record keeping.

- 5. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or with prior approval of the Director, another suitable measuring device at each point of diversion.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 6. The water user shall maintain the existing headgates and shall make such improvements as may be required by the Department.
- 7. The former place of use of the transferred rights shall no longer receive water under the rights.
- 8. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2017**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 9. When satisfactory proof of the completed changes is received, new certificates confirming the portions of the rights transferred under Certificates 75489, 76012, 76013, and 83857 will be issued.
