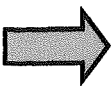

Describe the current water delivery system or the system that was in place at some time within the last five years. Water from Gooseneck Creek is stored in a reservoir, from which water is withdrawn and processed through a surface water treatment plant, which has a capacity of 120 gallons per minute. The distribution system is composed of mostly 6-inch waterlines and a storage tank. The District also has two wells and a recharge well. Water from the distribution system can be recharged into the groundwater aquifer for use during the summer.**

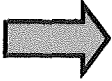
