Water is pumped from "bulge" temporary storage structures situated along the ditch by electric pumps and applied by a combination of mobile high pressure wheel lines and portable hand line laterals. In some areas, water is applied by gravity flood application; however, these areas are limited.



Source is to be Deer Creek in gravel, but will not be known until the wells are constructed. Each well is expected to provide approximately 1.05 CFS +/-, however that will not be known until the well(s) are completed.
