Due to too much slope on Reservoir #1 (R-14786), I am not going to move forward to construct it. However, I am moving forward on Reservoir #2 (R-14830) for a October 2012 construction date. Since my engineer has determined that Reservoir #2 can hold much more water than the permitted 12 acre feet, I would like to move the 15 acre feet of water from Reservoir #1 to #2 so as to make Reservoir #2 have a total of 27 acre feet. Kelly Starnes in your office told me that I can do this by using this form and paying the appropriate fees. It should be quite simple amendment since I have already been

approved for 27 acre feet of storage and since the reservoir #1 and #2 are only 50ft apart and have the same POD location from the small stream (tributary of Ash Swale). Basically, the POU and Dam Location for R-14786 just needs to "mirror" the POU and Dam Location for R-14830. The

dam height will still be under 10 feet.
