Another pipeline extends north-south between blocks and has laterals back to the west in two places. Application is mostly by drip to individual blackberry and blueberry plants. Southeast block is in blueberries and is currently irrigated with hand lines and sprinklers. It is set to be switched to low pressure overhead sprinklers in 2013. Irrigation is applied by blocks of 10-20 acres at a time.**
