

Description of Water Delivery System

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **The system consists of a concrete dam structure in Willow Creek that requires placement of 20' wide timbers to raise the water approximately 2-feet to a level that water will flow into my ditch that is controlled by a metal slide gate (2' wide 18"deep) with a screw stem. The canal at this point is 5' wide and 6' deep and a mile long. At the most northerly end the canal is reduced to 1'wide by 2' deep. With the use of canvas covered earth checks structures placed in the canal water is forced over the side of the canal flood irrigating the area of water right.**
