

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **Water is diverted at the Columbia River by six 600 HP motors into the Columbia Improvement District delivery system consisting of two booster stations with fifteen 700 HP motors each and 8 miles of 72 inch penstock welded pipe before dumping into an open canal (30' wide, 6' wide at bottom, and 8' deep.) The canal is approximately 8 miles long and has 9 pump stations for Boardman Tree Farms. Water is diverted at pump station 8 and 9 to deliver water to trees in Section 5, T3N 27E and Section 13, T3N 26E, W.M.**
