From the holding tank water is routed via the dairy (exempt stock watering use) to Slegers Sewage Lagoon. Water is then pumped with a 100 hp pump via an 8-inch pvc pipe to a Reinke center pivot with traveling guns. The center pivot and guns have a maximum capacity of 1000 gpm.**

Additional remarks: Certificate 39103 is for irrigation of 74.0 acres and supplemental irrigation of 30.7 acres. 53.8 acres of primary irrigation are to be converted to year round use in the dairy and barn. This amount of acreage corresponds to 0.67 cfs for the irrigation season, to prevent enlargement the rate will be reduced by 0.65 (240 days in irrigation season/365 days per year) to 0.44 cfs for year round use.

The to land/dairy already has one right under Cert 65621 (priority date 1977) the capacity of the dairy has increased since 1977 and additional water is needed.**
