The proposed use area is immediately north (same T2N, R13E, W1M, sec. 20 NE, NE + SE, NE) for the purpose of irrigating fresh market vegetable crops. (9.5 acres). 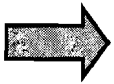

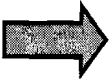
