

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **Orodell ditch takes water from the Grande Ronde River in the sw,sw of Section 31, T2S R38E, and transports the water easterly to the NE,NW quarter of Section 32. The water is then diverted from Orodell Ditch into a ditch that flows East in an unnamed ditch eventually flowing into Pierce Slough in my estimation in the NE, NE quarter of Section 33 T2S R38E. It is difficult to tell where the ditch turns into Pierce Slough. The water follows Pierce Slough Easterly into the SE,SE quarter of Section 27, where there is a 50 hp motor and centrifugal pump that discharges the water into 6" pvc mainline that discharges into a 10" buried mainline That flows North to the proposed lands that will be receiving the water. The mainlines are in place, and there will be a wheel line installed to irrigate the land.**
