

The City of Stanfield's water distribution system is a closed, pressurized system of underground water transmission and distribution lines. The system has two existing above ground steel water storage reservoirs. The reservoirs are supplied by ground water wells that provide water to the system based on an on-demand telemetry controlled system of well motor control units. The addition of Well No.5 as an APOA to this certificate and a new above ground steel water storage reservoir will greatly enhance the City's current water system.
