

In your own words tell us what change(s) you want made and the reason for the amendment(s): This application is requesting to change the place of use of a portion of the water rights described in Permit G-16465 to center pivots along the bottom ground in Eight Mile Canyon. The place of use of a portion of the acres being relocated in this application will coincide with the place of use of acres of Certificates 29964 and 80538 being transferred under a transfer application that is accompanying this permit amendment. These acres will be supplemental to the transferred acres associated with Certificates 29964 and 80538. This application also requests to use the Lemon Well (Well Logs Gill 64 & 65) described in Certificates 29964 & 80538 and a proposed new well as additional points of appropriation (POA).
