SUBJECT: Water Right Transfer Application T-11399

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-11399. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the Department's notice or 30 days after the last date of newspaper publication for T-11400, whichever is later.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On April 12, 2012, CARLTON NURSERY CO. LLC filed an application to change the place of use under Certificates 79467 and 79468. The Department assigned the application number T-11399.
- 2. Notice of the application for transfer was published on April 17, 2012, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On December 17, 2012, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11399 to the applicant. The draft Preliminary Determination cover letter noted some deficiencies in the maps that would need to be corrected before a Final Order could be issued. The cover letter set forth a deadline of January 17, 2013, for the applicant to respond. The applicant's agent clarified that a redescription of the right was being requested, and submitted revisions to the application and maps, as well as providing the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 4. Revised application pages and maps were submitted on January 2, March 6 and April 1, 2013.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 5. On April 11, 2013, the Department sent a copy of a revised draft Preliminary Determination proposing to approve Transfer Application T-11399 to the applicant. The revised draft Preliminary Determination cover letter also requested a replacement map (1 of 3). The applicant's agent requested that the Department proceed with issuance of a Preliminary Determination.
- 6. The portion of the first right to be transferred is as follows:

Use: IRRIGATION of 139.1 ACRES

Priority Date: NOVEMBER 10, 1961

Rate: 1.74 CUBIC FEET PER SECOND

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation

season of each year.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 14. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 15. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11399.
- 16. The proposed change would not result in enlargement of the rights.
- 17. The proposed change would not result in injury to other water rights.

Determination and Proposed Action

The change in place of use proposed in Transfer Application T-11399 appears to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-11399 is approved, the final order will include the following:

- 1. The change in place of use proposed in application T-11399 approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 79467 and 79468 and any related decree.
- 3. Water right certificates 79467 and 97468 are cancelled. New certificates will be issued describing portions of the rights not affected by this transfer.
- 4. The former place of use of the transferred rights shall no longer receive water under the rights.
- 5. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2014. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 6. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
