

Description of Water Delivery System

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **The project consists of 4 deep basalt wells. Wells 1, 2, and 3 are 16 inches in diameter and #4 is 18 inches in diameter. The wells are equipped with electrical 500 hp deep well turbines. Well 2 has a 50 hp centrifugal booster pump and well 3 has two 60 hp centrifugal booster pumps. The main and booster pumps deliver water to 23 center pivots of various lengths and several areas of wheel lines. The delivery system incorporates a small equalizing pond. The pond is located at an elevation that can provide adequate pressure to operate all but 3 of the center pivots.**


