measuring locations and the strategy for monitoring the instream flow or lake levels): <u>To avoid</u> injury, applicant requests that the instream rate protected be half of the maximum allowable rate. Therefore, the applicant requests that instream flow be allocated on a daily average basis of 0.33 CFS from June 19 through October 30. Because return flows from this portion of Lessor's property accrue to Pyles Creek, the applicant requests that no conditions be placed on the instream flow in Catherine Creek above the mouth of Pyles Creek. The instream right may be reduced downstream of the POD to account for channel losses if the watermaster determines this is necessary.
