Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **Orodell ditch takes water from the Grande Ronde River in the SW,SW of Section 31, T2S R38E, and transports the water easterly to the NE, NW Quarter of Section 32. The water is then diverted from Orodell Ditch into a ditch that flows East into a flume that diverts the water from Orodell ditch into Owslee Creek and eventually flowing into Pierce Slough in the NE, NE quarter of Section 33, T2S R38E. It is difficult to tell where the ditch turns into Pierce Slough. The water flows Pierce Slough Easterly into the SE, SE quarter of Section 27, where there is a 50 hp motor and centrifugal pump that discharges the water into a 6" PVC line that discharges into a 10" mainline that flows East across Hunter Road onto the Hill Property. The pump and mainlines are part of the Auston Bingaman system that delivers water to the handlines that are used on the Hill land. The mainlines are in place and have been used to irrigate the hill 11.5 acres.**
