The original application map shows Lot 2 as not receiving water as part of the group domestic expanded system, and Lot 10 as receiving water. Lot 10 has and is using water from an individual well on the property. Lot 2 is connected to the group system and is receiving water. 2. A water level monitoring and reporting plan was required to be submitted within 1 year of the permit. This was not accomplished until October 2008. We want the Water Resources Department to accept the submitted plan as satisfying the permit condition.
