Applicable Law

Any person or group of persons holding a water use subject to transfer as defined in ORS 540.505 may submit an application for an Allocation of Conserved Water to the Water Resources Commission for a conservation project that has not yet been implemented or was implemented within five years prior to the submission of the application. ORS 537.465. Under the Allocation of Conserved Water Program, a portion of the water proposed to be conserved by an applicant may be used on additional lands, put to a different use, or be leased or sold to another user. OAR 690-018-0010.

After determining any quantity of water needed to mitigate the effects on other water rights, 25-percent of the conserved water shall be allocated to the state and 75-percent to the applicant unless the applicant proposes a higher allocation to the state or more than 25-percent of the funds used to finance the conservation measures comes from federal or state sources. ORS 537.470(3).

An application for an allocation of conserved water shall include: (a) A description of the proposed measures; (b) A description of the existing diversion facilities and an estimate of the amount of water that can be diverted at the facilities; (c) The amount of water that will be needed for the original, authorized use after implementation of the conservation measures; (d) The amount of conserved water expected from implementation of the conservation measures; (e) The proposed allocation and use of the conserved water if different from the allocation specified in ORS 537.470; (f) The intended use of any water allocated to the applicant; (g) The applicant's choice of priority date for the conserved water; and (h) Any other information the commission considers necessary to evaluate the effectiveness of the proposal. ORS 537.465.

Pursuant to OAR 690-018-0050, any person objecting to the proposed allocation may file protest this Preliminary Determination to the Water Resources Commission within 60 days of the mailing of this determination.

If a person proposes conservation measures within the boundaries of an irrigation district organized under ORS chapter 545 or a water control district organized under ORS chapter 553, at the time the person submits the application, the person also must submit evidence that the district has approved the conservation application. ORS 537.465.

If an application for the allocation of conserved water is approved, the Department shall issue orders covering the changes in the original water rights and once the conservation project is finalized new certificates preserving the previously established priority of rights shall be issued to cover the unaffected portion of the water rights and separate new certificates describing the rights created by the allocation of conserved water. ORS 537.470(6).

ORS 537.455 to 537.500 authorize and establish the process in which a water right holder may submit a request for an allocation of conserved water. OAR Chapter 690, Division 18, implements the statutes and provides the Department's procedures and criteria for evaluating allocation of conserved water applications. OAR Chapter 690, Division 077 provides additional criteria for evaluating proposed instream water rights. The statutes and rules outlined above require the Department to review the application and any comments received to make its findings and determinations.

Findings of Fact

1. On April 17, 2012, North Unit Irrigation District (NUID) filed an Allocation of Conserved Water Application. The Department designated the application number CW-75.
2. The Applicant requests an Allocation of Conserved Water under Certificates 79279, 79280, 72283, and 72284 issued in the name of North Unit Irrigation District. Supplemental water right Certificates 72280 and 72281 are listed in the application, but will not be modified by Allocation of Conserved Water Application CW-75.
3. The Applicant proposes to conserve approximately 12,505 acre-feet (AF) of water by lining a canal and improving the overall efficiency of the delivery system.

The first step in the conservation project involves lining the sides of the NUID main canal from canal mile 6.9 to canal mile 11.8. Lining approximately five miles of the NUID main canal is expected to eliminate 7,880 acre-feet of seepage loss from the Deschutes River.

The second step in the conservation project will likely result in the conservation of 12,504.55 acre-feet of Crooked River water. Conservation of the Crooked River water will be achieved by using the more efficient, gravity fed NUID main canal to deliver the 7,880 acre-feet of Deschutes River water saved by canal lining to 3,152 acres, which currently receive 4.0 acre-feet per acre of Crooked River water. The Applicant proposes to dedicate 100% of the conserved Crooked River water to the state as a new instream water right.

Application of Crooked River water to NUID lands can only be achieved by the use of costly electric pumps. The use of electric pumps requires the District to purchase electricity from a local, coal-fueled power plant. Deschutes River water can be applied to NUID lands via the gravity fed NUID main canal system. Limiting the District's reliance on electric pumps in

favor of the gravity fed delivery system will greatly improve the efficiency of the NUID delivery system.

Canal lining and improving the overall efficiency of a delivery system are both proven water conservation techniques.

4. The entirety of the first right to be modified is as follows:

Certificate: 72279 in the name of NORTH UNIT IRRIGATION DISTRICT, perfected under Permit S-23196

Use: IRRIGATION of 49,916 Acres

Priority Date: FEBRUARY 28, 1913

Rate: 1101.00 CUBIC FEET PER SECOND, together with all other rights perfected under Permit 23196 shall not exceed 1,101.0 cfs, measured at the points of diversion from the sources.

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 5.25 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is further subject to the terms and conditions of the State Engineer's Orders dated January 20, 1955 and February 4, 1955.

Rate: 3.35 CUBIC FEET PER SECOND, together with all other rights perfected under Permit 23196 shall not exceed 1,101.0 cfs, measured at the points of diversion from the sources.

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 5.25 acre-feet per acre for each acre irrigated during the irrigation

season of each year, and is further subject to the terms and conditions of the State Engineer's Orders dated January 20, 1955 and February 4, 1955.

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is further subject to the terms and conditions of a stipulation between North Unit Irrigation District and the Oregon State Game Commission which has been recorded in the Miscellaneous Records of the Water Resources Director.

8. Water right Certificates 72279, 72280, 72283, and 72284 have been modified by multiple transactions, which may have reduced the rates and duties of the rights. The Application does not describe how the affected rights have been modified by cancellations, transfers, or other allocation of conserved water projects.
9. On February 4, 2004, the Department issued a Final Order Approving Allocation of Conserved Water Application CW-24, recorded at Special Order Volume 59, Pages 184-194. CW-24 resulted in conservation of the following quantities of water:

10. Deschutes River water right Certificate 72279 is limited to a diversion of 1,101.00 cfs. The quantity of water available for diversion under Certificate 72279 must be reduced to account for the conservation under CW-24, being 1.70 cfs. The new diversion rate for Certificate 72279 will be 1,099.30 cfs.
11. Deschutes River Water Right Certificates 72279, 72280, and all other rights perfected under Permit S-23196 are limited to a combined maximum diversion of 1,101.00 cfs. To avoid enlargement, the maximum quantity of water available for diversion under Water Right Certificates 72279 and 72280, and any other rights perfected under Permit 23196 must be reduced to account for the conservation under CW-24, being 0.85 cfs. The new maximum combined rate of diversion for all rights perfected under Permit 23196 will be 1,100.15 cfs.
12. On May 7, 2010, the Department issued Special Order Volume 80, Pages 901-902, approving a Partial Cancellation of Certificate 72283. The Final Order reduced Crooked River water right Certificate 72283 by 0.5 acres, 0.01 cfs, and 2.0 acre-feet.
13. Crooked River Water Right Certificate 72283 is limited to a diversion of 200.0 cfs. The quantity of water available for diversion under Certificate 72283 must be reduced to account for the conservation under CW-24, being 1.74 cfs. In addition, the rate must be reduced 0.01 cfs for the partial cancellation described above. The new diversion rate for Certificate 72283 will be 198.25 cfs.
14. Crooked River water right Certificates 72283, 72284, and all other rights perfected under Permit S-33954 are limited to a combined maximum diversion of 200.00 cfs. To avoid

enlargement, the maximum quantity of water available for diversion under water right Certificates 72283 and 72284 and any other rights perfected under Permit S-33954 must be reduced to account for the State's portion of conserved water under CW-24 being 0.87 cfs and the quantity of water abandoned under Special Order Volume 80 at Pages 901-902, being 0.01 cfs. The new maximum combined rate of diversion for all rights perfected under Permit 33954 will be 199.12 cfs.

16. Any previously approved or pending transfers, cancellations, allocations of conserved water, or other modifications to Certificates 72279, 72280, 72283, and 72284, not listed above will cause a corresponding change to the rate, duty and total number of acres served by these rights.
17. On October 7, 2008, NUID adopted an Allocation of Conserved Water Policy that conforms to the requirements of OAR 690-018-0025.
18. Diversion structures, canals and ditches sufficient to deliver the full quantity of water allowed under the existing rights were present within the five-year period prior to submission of Allocation of Conserved Water application CW-75.
19. On March 28, 2012, the Applicant provided notice of the proposed conservation project to the Land Use and Planning Departments of Crook, Deschutes, and Jefferson Counties as required by OAR 690-018-0040(22).
20. Notice of the proposed conservation project was published in the Department's weekly notice on May 8, 2012, and in *The Bulletin* newspaper on June 3 and 10, 2012, as required under OAR 690-018-0050.
21. On May 29, 2012, WaterWatch of Oregon filed comments expressing concerns about NUID's ability to divert the quantity of water from the Crooked River and the potential

impacts the proposed canal lining project may have on instream rights in the lower Deschutes River.

22. On June 13, 2012, the Applicant provided additional evidence sufficient to establish that the District has the ability to pump the full 200.0 cfs from the Crooked River as allowed by water right Certificates 72283 and 72284. Specifically, the District has ten, 450 horsepower pumps, each pump has a 22 cfs capacity (10 pumps x 22 cfs per pump = 220 cfs maximum capacity).
23. The Applicant has the capacity to divert the full quantity of water available under the subject rights. Department staff has also determined the subject rights could be applied to the authorized beneficial uses at the maximum rates and volumes allowed without return flows.
24. The canal lining portion of the project will eliminate the following quantities of seepage loss from the Deschutes River:

27. Allocation of Conserved Water Project CW-75 is complete and resulted in 12,504.55 acre-feet of conserved water under Certificates 72283 and 72284. Pursuant to OAR 690-018-0012(1), the Applicant requests that 100% of the conserved water be dedicated to the state as a new instream water right.

28. Pursuant ORS 537.485, the Applicant requests that the priority dates of the conserved water be the same as the originating rights.

29. On June 14, 2012, the District 11 Watermaster reviewed Allocation of Conserved Water Application CW-75 and determined that the conservation project would result in conserved water which could be allocated without harm to other rights. However, consumptive use of the seepage water conserved could result in a potential reduction to wintertime flows in the Lower Deschutes River.

- a. The proposed allocation of conserved water will not harm existing out-of-stream or instream water rights in the Upper Deschutes (above Bend) or Middle Deschutes River (above Lake Billy Chinook) because the downstream return flows do not re-enter the Deschutes River above Lake Billy Chinook.
- b. Out-of-stream rights in the Lower Deschutes (below Lake Billy Chinook) are not harmed since there is always sufficient flow for these rights. Instream flows in the Lower Deschutes are not harmed because the project will not result in any increase to consumptive use of water and because the new instream right created on the Crooked River by this project will result in greater instream flows from the authorized point of diversion to the mouth of the Deschutes River.
- c. Some of the water which was previously diverted, and which will no longer be diverted, could have returned to the Lower Deschutes River outside of the irrigation season and could have slightly increased wintertime flows in the Lower Deschutes River. However, the diversion of water is not required and, therefore, the return flows are not required. Moreover, any potential reduction to wintertime return flows is more than offset by the new instream water right created by CW-75.
- d. The Oregon Departments of Environmental Quality, Fish and Wildlife, and Parks and Recreation, in conjunction with the United States Bureau of Reclamation, have determined that the water quality in the Lower Crooked River during the mid- to late summer months is severely degraded due to low flows and corresponding high

temperatures. The new instream right created by this project will enhance streamflows in Lower Crooked River. Increasing mid- to late summer flows in the Crooked River will increase water quality in the Lower Crooked River and in the Lower Deschutes system. The increased water quality in the Deschutes River system as a whole will more than offset any potential reduction in attenuated return flows in the Lower Deschutes River.

30. The Applicant proposed the following conditions or limitations to mitigate for potential harm to existing water rights:

- a. The North Unit Irrigation District (NUID) Water Accounting agreement dated July 12, 1996, requires NUID to pump 16.475% of the total irrigation demand from the Crooked River. The Agreement shall be amended and pro-rated according to the quantities of water used after completion of this project. Upon approval and finalization of this project, NUID shall be required to pump 10.585% of the total irrigation demand from the Crooked River.
- b. North Unit Irrigation District and the Deschutes River Conservancy have agreed that the new instream right created by this Allocation of Conserved Water project will be in addition to historic minimum stream flows in the Crooked River as defined in the “Dry Year” “Non-Dry Year” agreement described in Attachment 3, to Allocation of Conserved Water Application CW-75. The quantity of water that must be by-passed will be determined by the Department’s District 11 Watermaster office. Prior to March 31 of each year, the District 11 Watermaster shall determine the quantity of water that must be by-passed in accordance with the “Dry Year” “Non-Dry Year” agreement described in Attachment 3, to Allocation of Conserved Water Application CW-75.

31. The proposed allocation of conserved water project, as described above, will not harm existing water rights; therefore, no reduction in the quantity of conserved water to be allocated is required to mitigate effects on other water rights.

32. In consultation with the Oregon Department of Fish and Wildlife (ODFW), Department of Environmental Quality (DEQ), and Oregon Parks and Recreation Department (OPRD), the Department has determined that the greatest benefit to the Deschutes River system as a whole will be achieved by protecting the new instream right from the NUID point of diversion to the mouth of the Crooked River at its confluence with the Deschutes River. The new instream right will improve water quality, reduce water temperature, and provide additional benefits for fish, wildlife and other aquatic resources.

33. The DEQ indicated that temperatures in the Crooked River are elevated above state water quality standards during summer months due to low flows below the NUID point of diversion and that additional flows would improve temperature related water quality problems.

34. The combination of instream rights for the proposed reach on Crooked River does not exceed the amount needed to provide increased public benefits and is consistent with Sections (4), (5) and (6) of OAR 690-077-0015.

35. The proposed instream right is not a measurable portion of the Deschutes River as required by OAR 690-077-0015(8). Therefore, the proposed instream right cannot be extended from the Crooked River into the Deschutes River.
36. Pursuant OAR 690-077-0015(8) the stream reach for the instream right on the Crooked River shall be from the authorized point of diversion located at approximately River Mile 27.5:

37. The right will be protected instream from April 1 through October 31. To avoid enlargement, the rates to be protected instream have been determined by the following calculation: (volume ÷ 1.983471 (cfs equivalent) ÷ 214 days (irrigation season) = new rate). The rate for the instream water right shall be as follows:

38. Pursuant to OAR 690-018-0062, the Applicant indicated that the project is complete and requested that the project be finalized.

Allocation of Conserved Water Review Criteria [OAR 690-018-0050]

Pursuant to ORS 537.465 and OAR 690-018-0050, the Department has reviewed the application and considered any comments received and has determined:

39. Allocation of Conserved Water Application CW-75 contains all the information required by OAR 690-018-0040.
40. As established in Findings of Fact #24 and #25, the proposed Allocation of Conserved Water project will result in a reduced diversion for the uses allowed under the original rights. OAR 690-018-0050(4)(a)
41. Consistent with Finding of Fact #29, the proposed Allocation of Conserved Water will not harm existing water rights. Therefore, no reduction in the quantity of conserved water to be allocated is required to mitigate for the effects on other water rights. OAR 690-018-0050(4)(b) and (d).
42. As established in Finding of Fact #19, CW-75 is consistent with the requirements established in OAR 690-005-0045 (Standards for Goal Compliance and Compatibility with Acknowledged Comprehensive Plans). OAR 690-018-0050(4)(c).

43. Because the conserved water was developed from delivery system efficiencies, the rate and volume for Certificates 72279 and 72280 must be modified. The new rate and volume are as follows:

45. In consultation with ODFW, DEQ and OPRD, the Department has determined that the conserved water is needed to support instream uses. (Findings of Fact #32 and #33). OAR 690-018-0050(4)(f).

46. Consistent with ORS 537.470(3), the Applicant requests that 100% of the conserved water be allocated for an instream water right to be held in trust by the Water Resources Department for the people of Oregon and that the priority date of the instream right will be the same as the originating rights. (Findings of Fact #27 and #28). OAR 690-018-0050(4)(g).

47. Consistent with OAR 690-077-0015(8) and (10), the State's portion of the conserved water shall have a priority date of September 18, 1968, and shall be allocated as an instream water right for maintenance and enhancement of aquatic habitat, fish, wildlife, wildlife habitat and other ecological values, and pollution abatement. The instream water right shall provide for the protection of flows in the Crooked River from the authorized point of diversion at:

- for instream use and protection of flows from April 1 through October 31. (Findings of Fact #36 and #37). OAR 690-018-0050(4)(h).
48. The instream right to be created by Allocation of Conserved Water Project CW-75 is consistent with the criteria for establishment of an instream right as outlined in OAR 690-077-0015. (Findings of Fact #32 through #37).

49. Pursuant OAR 690-018-0062 the Applicant notified the Department that the Allocation of Conserved Water Project is complete and requested finalization of the project. (Finding of Fact #38). OAR 690-018-0050(4)(i).
50. The following conditions and limitations proposed by the Applicant, mitigate for potential harm to existing rights, and are acceptable to the Department:

The North Unit Irrigation District (NUID) Water Accounting agreement dated July 12, 1996, requires NUID to pump 16.475% of the total irrigation demand from the Crooked River. The Agreement shall be amended and pro-rated according to the quantities of water used after completion of this project. Upon approval and finalization of this project, NUID shall be required to pump 10.585% of the total irrigation demand from the Crooked River.

North Unit Irrigation District and the Deschutes River Conservancy have agreed that the new instream right created by this Allocation of Conserved Water project will be in addition to historic minimum stream flows in the Crooked River as defined in the "Dry Year" "Non-Dry Year" agreement described in Attachment 3, to Allocation of Conserved Water Application CW-75. The quantity of water that must be by-passed will be determined by the Department's District 11 Watermaster office. Prior to March 31 of each year, the District 11 Watermaster shall determine the quantity of water that must be by-passed in accordance with the "Dry Year" "Non-Dry Year" agreement described in Attachment 3, to Allocation of Conserved Water Application CW-75.

(Finding of Fact #30) OAR 690-018-0050(4)(j).

Determination and Proposed Action

1. The project described in Allocation of Conserved Water Application CW-75, is consistent with the criteria in ORS 537.455 to 537.500 and OAR Chapter 690, Division 018.
2. Pursuant OAR 690-018-0050(4), the conservation project will conserve water and, as described in Findings of Fact #29, and as conditioned in Finding of Fact #50, can be allocated without harming existing water rights.
3. Consistent with ORS 537.470(3), the State's portion of the conserved water is necessary to support instream flow purposes in accordance with ORS 537.332 to 537.360.

If approved, the change and subsequent use of water shall be subject to the following:

1. *The changes proposed in Allocation of Conserved Water CW-75 are approved.*

2. *The project is complete and is finalized.*
3. *The right to the use of water is restricted to beneficial use at the unmodified place of use described in Certificates 72283 and 72284, and is subject to all other conditions and limitations contained in Certificates 72283 and 72284, and any related decree.*
4. *Water Right Certificates 72283 and 72284 are cancelled. New Certificates will be issued for those portions of the rights not affected by Allocation of Conserved Water CW-75 at the following rates and duties:*

9. *The water user shall maintain and operate the existing measurement device at the point of diversion on the Deschutes River and shall make such improvements as may be required by the Department.*
10. *The applicant shall allow the Watermaster access to the meters or measuring devices. Where a meter is located within a private structure, the Watermaster shall be granted access upon reasonable notice.*



NOTICE OF RIGHTS

The Legislative Assembly finds that persons affected by actions taken by state agencies have a right to be informed of their rights and remedies with respect to those actions. ORS 183.415.

The commission shall notify the applicant and any other person requesting notice, of the action the commission intends to take under ORS 537.470(3). Any person objecting to the proposed allocation may file a protest requesting a contested case hearing before the commission. ORS 537.470(4).

If a protest to the proposed allocation of conserved water is received by the Department within 60 days of the mailing of the preliminary determination pursuant to ORS 537.470(4) and OAR 690-018-0050(4), the Director may work with the applicant and any protestant to determine whether the issues can be resolved through mutually agreeable conditions, or by modifying the application. OAR 690-018-0050(6).

If protests are received raising issues that cannot be resolved pursuant OAR 690-018-0050(6), the Director shall present the application, all protests and a recommendation for action to the Commission for review and action. OAR 690-018-0050(8).

The Commission shall examine the application, the protests and the Director's recommendation. If the Commission finds the allocation of conserved water is likely to injure existing water rights or is otherwise inconsistent with these rules, the Commission may direct the Department to hold a contested case hearing on the application pursuant to ORS 183.413 and OAR 690, Divisions 1 and 2 or to resume attempts to resolve the disputed issues. If the Commission finds the allocation of conserved water is not likely to injure existing rights and is otherwise consistent with OAR 690-018-0050, the Commission may authorize the Director to issue an order approving the application. OAR 690-018-0050(9).

In the event of a land use dispute, as defined in OAR 690-005-0015, the Director shall follow resolution procedures provided in 690-005-0040 (Resolution of Land Use Disputes). OAR 690-018-0050(10).
