- For irrigation calculate cfs for each water right involved as follows:



### Purpose of the Proposed Exchange of Water:

Explain in your own words what you propose to accomplish with this exchange application and why: This exchange involve one water right only. The purpose is to move point of diversion for 14982 Highway 42 (residence) from two unnamed springs which are tributaries to an unnamed stream. The unnamed stream is a tributary to the Coquille River. The new point of diversion will be closer to the residence and divert water directly from the Coquille River. This will solve problems with the current water distribution system. This exchange will also allow for lower maintenance cost and more flow to remain in the unnamed stream.
