Explain in your own words what you propose to accomplish with this transfer application, and why:

Chris and Kathy Scheller purchased Tax Lot 800, Sec. 31, T 2S, R 1E, W.M. (see enclosed application map) located entirely and within a portion of Certificate 62489.

They wished to continue irrigation pursuant to C-62489; however the current owner of the well, Mr. Oldenstadt, serving that Certificate was unwilling to supply water to their property.

As a result, the Schellers completed a new well (CLAC-54913) on August 24, 1999, and began using the new well water for domestic and irrigation purposes on lands shown in the application map.

Watermaster Greg Beaman advised the Schellers that they needed a Transfer to confirm their right to use water in this manner from CLAC-54913. Upon approaching Mr. Oldenstadt for approval to transfer a portion of his right, it became apparent that his voluntary consent could not be obtained.

Accordingly, the Schellers now propose to add a point of appropriation (POA) to C-62489 and identify their portion of C-62489 irrigated, namely Tax Lot 800, on the Transfer.

TL 800 is entirely in the SE NW  $\frac{1}{4}$   $\frac{1}{4}$  of Section 31 and originally comprised 4.92 acres of irrigated land. Upon construction of their home, outbuildings, driveways and other features, the barlo and at a acres.




