The description referred to in Question 14 above is as follows: Commencing at the Northeast corner of Section 34, Township 1 North, Range 32, E.W.M thence South 89°50'01" West a distance of 2397.33 feet to a point on the centerline of the existing county road No. 549 and the centerline of an irrigation ditch culvert and thence along the centerline of an irrigation ditch the following bearings and distances: South 13°04'40" East 103.22 feet; South 9°18'30" West 68.19 feet; South 26°14'28" West 226.88 feet; South 14°03'05" West 1009.65 feet; South 44°43' 51" West 78.30 feet to the center of the concrete head wall of the diversion structure at Birch Creek the terminus point for this description, and being the point of diversion point of diversion.
