Explain in your own words what you propose to accomplish with this transfer application, and why: The applicant proposes to relocate the POD approximately 1.25 miles downstream and eliminate the existing 5 foot concrete dam and diversion structure. The landowner (Pine Meadow Ranch Inc.) is the sole water right holder on this POD. Since the existing dam is a fish passage barrier, its elimination will provide fish in Whychus Creek access to 13 miles of upstream habitat. Also, the Upper Deschutes Watershed Council (UDWC) and the Forest Service plan to implement a comprehensive restoration of habitat between the existing and proposed POD's, where the channel has been significantly altered to accommodate irrigation diversions. At the proposed POD, pipe will convey diverted water to the place of use for the surface water rights associated with this diversion, eliminating 100% of the ditch losses associated with the existing ditch. The Deschutes River Conservancy (DRC), on behalf of PMR, plans to apply for 1 cfs of conserved water resulting from eliminating ditch losses and allocate 100% of the conserved water to permanent instream use in Whychus Creek.

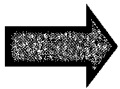
