confirms the right to use the water from POND "A", a tributary of COLD SPRINGS RESERVOIR, for the purpose of SUPPLEMENTAL IRRIGATION of 38.7 acres.

This right was perfected under Permit 30267. The date of priority is December 9, 1964. This right is limited to an amount of water actually beneficially used for said purposes, and shall not exceed 0.96 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located 1340 feet South and 1060 feet West from the Northeast corner of Section 11, being within the SE1/4 NE1/4 of Section 11, Township 4 North, Range 29 East, W.M.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

This certificate confirms an order of the Director entered on 4-7, 1998 and recorded in Special Order Volume 52, page 348, approving a petition by Stanfield Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate, together with Certificate 74658, supersedes certificate 38742 State Record of Water Right Certificate.

**Notice of Four-Year Consecutive Non-Use of Water and
Intent to Transfer Pursuant to ORS 540.572**

Pursuant to ORS 540.572, whenever land within the legal boundaries of an irrigation district is no longer irrigated or susceptible to irrigation, the irrigation district may apply the certificated water to which such land is entitled to other irrigable lands within the legal boundaries of the district.

The Stanfield Irrigation District ("District") hereby notifies PAUL & NATALIE LAPP (referred to herein as the "User(s)"), that water has not been put to beneficial use on certain lands that are otherwise entitled to use water for a period of four successive years. If the User does not use the water for a fifth successive year, the district intends to petition the Water Resources Commission for a transfer of the water right pursuant to ORS 540.574 before the end of the fifth consecutive year of nonuse.

Pursuant to ORS 540.572 and OAR 690-385-5100, the District hereby provides notice of the following:

(a) The District has determined that the User's land is no longer irrigated or susceptible of irrigation and that the District intends to submit an application to permanently transfer the water right pursuant to ORS 540.572;

(b) The User has 30 days from the mailing date of this Notice to submit to the District a written objection to the proposed transfer application;

(c) The User has 30 days from the mailing date of this Notice to notify the District in writing if the User intends to demonstrate that the nonuse is excused by one of the provisions under ORS 540.610;

(d) The User may demonstrate beneficial use of the water right by:

(i) Beneficially irrigating the lands to which the water right is appurtenant prior to the end of the irrigation season of the fifth consecutive year of nonuse, or

(ii) Making beneficial use of water under one of the qualifying programs of the Water Resources Department such as, but not limited to, submitting a water right transfer under OAR 690, division 380 or a transfer to instream use under OAR 690, division 077, prior to the end of the irrigation season of the fifth consecutive year of nonuse (so long as such use is consistent with the District's policies, rules and regulations, and contractual obligations to the U.S. Bureau of Reclamation);




