Explain in your own words what you propose to accomplish with this permit amendment; and why: The DeLints have purchased an adjoining farm without water. The DeLints wish to transfer lands under Permit G-15808 onto the new lands, and transfer one well location onto the new lands to better distribute the water. The DeLints have applied for primary water to replace the 229.5 acres being transferred to the new lands, from an existing deep basalt well "Union 50687" to water the lands being vacated by this amendment. That application is in the process. Marcus DeLint has also applied for a deep basalt well for supplemental water. This is also in process. Well # 4 has been drilled, but has been moved within the 40. We are applying for an amendment for Well # 4 location. I find no well log for Well # 4, which has a tag attached, L- 100217. I am unable to attach a well log.


