

Water is delivered through open ditches operated by the Lost and Boulder Ditch Improvement District to the property. The was a 60 horsepower centrugal pump on the pond at the western boundary that was used for the center pivot system by Jack Stevens. A 40 horsepower centrifugal pump runs the drip irrigation system in the orchard now. This will put out about 700 gpm.
