



### Description of Water Delivery System

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **The current system consists of a 30hp electric motor-pump located at the POD and 23 each Rainbird 30 sprinkler heads with 1/8" nozzles. The intake in Beaver Creek has an approved fish screen. The water is distributed to the 3.4 acres outside the Wetland Reserve Program by 690 feet of 5" aluminum above-ground mainline and 920 feet of 3" handlines fitted with 23 Rainbird 30 sprinkler heads with 1/8" nozzles. Calculation of the system capacity assumed 60psi at the 23 sprinkler heads. The 30hp pump is capable of providing 1.22cfs of water at 60psi than the 23 sprinklers can output. Calculations are therefore limited to the maximum table value of 60psi for these sprinklers. The pump will be used in irrigation of the "TO" transfer area.**

*Explain in your own words what you propose to accomplish with this transfer application, and why.*

Of the 26.0 acres covered by this water right, 22.6 acres is under contract with the USDA- Natural Resources Conservation Service Wetland Reserve Program (WRP) since 1998 and is not available for irrigation. We have irrigated the remaining 3.4 acres, shown on the Transfer Application Map, within the last 5 years. Irrigation during 2004 is depicted in the attached pictures. See Benton County Survey No. 9391 for location of the WRP area and the 3.4 acres excluded from the WRP.

We wish to transfer the entire water right of 26.0 acres from the existing area to another area outside the WRP area and continue irrigation of crops and pasture.

We wish to rebut presumption of forfeiture of the 22.6 acres for non-irrigation and use of water under OAR 690-017-0080 (2)(d) as the land was withdrawn from use under the Wetland Reserve Program, Contract No. 66-0436-8-8808.
