

 A vineyard will be planted to grow on trellis lines set on eight feet centers. Drip irrigation will be attached to the trellis lines and will irrigate two feet each side, which will leave a four feet wide dry strip between trellis rows. There will be 8.45 acres of irrigation remaining unchanged by this transfer, and 8.45 acres will be moved to a new place of use on adjacent lands within Tax Lot 300 as shown on the attached maps. A permanent transfer will be obtained during the time that this temporary transfer is in place.

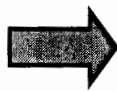
