 We wish to transfer the place of use and character of use for Certificate 55246 from domestic use with irrigation for one family and 1/2 acre of lawn and garden, to: human consumption in three buildings. The current points of diversion will remain.

Two buildings have been added to the property and are in need of a water supply. This area has poor groundwater conditions that prevent a new groundwater source and additional surface water rights are not available.

Describe the current water delivery system or the system that was in place at some time within the last five years. Water is diverted from an unnamed spring approximately 200 verticle feet above the place of use and conveyed via gravity flow to two 2,000 gallon storage tanks through approximately 300' of 1.25" pipe. The water is then delivered to the place of use via gravity flow through approximatley 400' of 2.0" pipe. In addition, when spring flows are not sufficient, water is diverted from the South Fork of Little Butte Creek using a 2HP pump and conveyed to the same storage tanks via approximately 700' of 1.25" pipe where it enters the distribution system. See attached rate calculation sheets.
