


Additional remarks: Because of the poor quality of the available maps for this GR, the map accompanying this application has been prepared using certain assumptions. The basic footprint of the original maps available in the Department file appear to conform with the general shapes of the subject lot (Lot 500, Tax Map 5 3 16) and adjacent properties. One of the assumptions made when preparing the application map is that the entire 14.0 acres within the subject property is covered by GR-1753. This assumption is based on a consideration of the total acres included in GR-1753 (23.0 acres), the number of acres designated in the portion on the west side of SE Wallace Road (4.0 acres), and the apparent size of the place of use which lies within the subject property as compared with the small place of use which lies in the adjacent lot to the south. The result is that the acreages by quarter quarter section differ from those described in GR-1753.
