



Additional remarks: Temporarily transferring 49.8 acres of water rights to leased grounds for crop rotation. The TO lands in Section 17 and 18 (Tax Lot 4600) have an existing groundwater right (Certificate 87023) that has been removed under temporary transfer T-11537. The TO lands in Section 20 have existing surface water rights (Certificates 81632 and 87425) that will not be used for the duration of this current temporary transfer. The owner of Tax Lot 4800 in Section 19 has given the applicant permission to use her well as the proposed point of appropriation (Rayburn well) to accommodate the place of use transfer, as we are also leasing her ground to complete the semi-circle proposed for all of the TO lands. Her grounds are included in a separate temporary transfer application.
