

Explain in your own words what you propose to accomplish with this transfer and why:

We propose to irrigate from three center pivots as shown on the application map. The south pivot will irrigate 63.8 acres under C-28451 from that same authorized well, (Well #1), with no change in the place of use. The remaining 38.7 acres will be transferred to a the new Place of Use located within coverage of the south pivot. This will more efficiently irrigate these lands.

Jointly filed with this transfer application is an Application for Permit to Use Ground Water from Well #1 and Well #2.

Well #1 will supply new ground water to 19.8 acres within coverage of the south pivot.

Well #2 will supply new ground water to the middle and north pivots. This includes 1.6 acres transferred from C-28451 within coverage of the middle pivot..
