Explain in your own words what you propose to accomplish with this transfer application, and why: I wish to change the point of diversion from Farmers Ditch to Silver Lake Ditch in order to irrigate my land using gravity for pressure to run my wheel lines. Currently portions of my land are irrigated from both Farmers Ditch and Silver lake Ditch. This will enable me to irrigate more effeciently and with less water via sprinklers, and will be easier to administer. The NRCS is rebuilding the distribution system which is currently under design. Construction is now complete. There is currently an 8" pipeline that picks up water from Silver Lake Ditch that is to be used in this transfer, and the water will be pumped to the lands listed on this transfer.

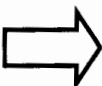

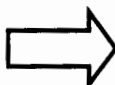

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **Currently water is pumped from FARMERS DITCH using a 50 HP Centennial electrical motor and a 4" Centrifugal pump. The water enters the line through a screened suction to the pump, and then enters an underground 8" pvc line with risers extending North for approximately 1320 feet and reduces down to a 6" pvc and runs North for another 1300 to 1500 feet to the end of the irrigated property. There is also an 8" water line that picks up SILVER LAKE WATER from the South Ditch and transports the water to the formentioned pump, which in turn pumps the water into an 8" underground pvc line for distribution onto the Southern most 30 acres of the mapped land. There are 4 existing wheel lines that distribute the water on the irrigated land. This system has been in operation for many years.**
