Certificate of Water Right Ownership Update

NOTICE TO SELLERS & BUYERS:

JUL 2 1 2014

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the OR land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. If for multiple rights, a separate form for each right will be required.

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES FREDERIC 27083 HIGH DECK RD FOSTER OR 97345

confirms the right to use the waters of UNNAMED STREAM, tributary to SOUTH SANTIAM RIVER for DOMESTIC USE FOR TWO FAMILIES AND THE IRRIGATION OF 0.3 ACRE.

This right was perfected under Permit 41650. The date of priority is MARCH 29, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.02 CUBIC FOOT PER SECOND (CFS), being 0.01 CFS FOR EACH USE, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning of construction and installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director at Special Order Volume 48, Pages 348 – 349, and Page 382, approving Transfer Application 7213, and supersedes Certificate 61707, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right. **RECEIVED BY OWRD**



The following described real property situated in the County of Linn and State of Oregon, to wit:

Beginning at a 3/4" iron pipe which is on the North line of and South 89°49.5' East 5.7548 chains from the Northwest corner of the Southeast quarter of Section 36, Township 13 South, Range 2 East of the Willamette Meridian in Linn County, Oregon; and running thence South 89°49.5 East along said subdivision line 8.9227 chains to a 3/4" iron pipe (which iron pipe is North 89°49.5' West 24.8615 chains from the Northeast corner of said Southeast quarter of said Section 36); thence South 0°31.69' East 20.8227 chains to the center of the County Road; thence South 19°00' West 2.20 chains to a point in the center of the South Fork of the South Santiam River (from which point a 3/4" iron pipe bears North 19°00' East 1.9727 chains); thence North 60°04' West down the center of said river 9.6664 chains to a point (from which point a 3/4" iron pipe on the right bank of said river bears North 0°04' West 2.2728 chains); thence North 0°04' West 18.1056 chains to the place of beginning.
