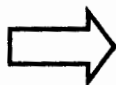

Describe the current water delivery system or the system that was in place at some time within the last five years. Water is pumped from Well 2 (YAMH 56664) by a 30 Hp submersible pump. The water is then conveyed through 6" portable aluminum mainlines through culverts under the creek, as shown on the application map. From these mainlines, 3-inch aluminum laterals equipped with impact sprinklers are connected.**


